SUMMARY

The allocation of grants contained within this Decision Notice are from the Small Grants Funding scheme (which includes Biodiversity, Carbon Reduction, Community Chest, Community Planning, and Twinning) and are within the approved overall budget.

No applications have been received towards Biodiversity or Twinning schemes.

Please note that in order to support all eligible applications in this round it has not been possible to award the full amount of grant requested to all Community Chest applicants.

PROPOSED DECISION

1. It is recommended that the following grant be awarded from the Carbon Reduction Grant Scheme:

Alresford & District Community Association

Amount Requested: £500 Amount Awarded: £500

Funding recommended towards the cost of roof insulation which will help reduce the CO₂ emissions from the energy used in heating the building.

Future Proof Bishops Waltham Amount Requested: £500 Amount Awarded: £500

Funding recommended towards a project which will provide the opportunity to involve the community in CO₂ reduction through three avenues that can attract different audiences.

Winchester Action on Climate Change

Amount Requested: £500 Amount Awarded: £500

Funding recommended towards a two day event for local people which will provide information and explore the contribution that individuals can make to carbon reduction initiatives.

2. It is recommended that the following grants be awarded from the **Community Chest scheme**.

12th Winchester (Greenjackets) Scout Group

Amount Requested: £500
Amount Awarded: £400

Funding recommended towards improvements to the community building which will improve access for people with disability problems as well as addressing health and safety issues.

Bishops Waltham Gardening Club

Amount Requested: £500 Amount Awarded: £400

Funding recommended towards the provision of raised bed for disabled and wheelchair bound people, as well as a number of small raised allotment beds for children.

Club Hampshire

Amount Requested: £270 Amount Awarded: £200

Funding recommended towards activities for the elderly.

Colden Common Community Association

Amount Requested: £500 Amount Awarded: £400

Funding recommended towards the purchase of a film projector in order to host film nights for local residents and which will be shared with other local community associations.

North Winchester Youth and Community Action

Amount Requested: £498.96 Amount Awarded: £400

Funding recommended towards activities for young people in the North Winchester area.

The Handless Maiden Project Amount Requested: £500 Amount Awarded: £400

Funding recommended towards an art project with homeless people.

Triangle Pre-School

Amount Requested: £434.93 Amount Awarded: £300

Funding recommended towards the purchase of outdoor play equipment.

Wickham Youth Club

Amount Requested: £500 Amount Awarded: £400

Funding recommended towards the purchase of materials and equipment for art and handicraft sessions as well as storage facilities for them.

Winchester & District Over 55's Forum

Amount Requested: £500 Amount Awarded: £500

Funding recommended towards two events, one focusing on older people's health issues, and another focusing on increasing the self esteem of older people within the district.

Winchester Chamber Music Festival

Amount Requested: £500 Amount Awarded: £400

Funding is recommended towards outreach work with local schools prior to this festival in order to provide an opportunity for children and young people to access this style of music.

Winchester City Flyers Football Club Amount Requested £498.75 Amount Awarded: £400

Funding recommended towards the cost of first aid training and equipment to enable the creation of an Under 10 girls football team.

REASON FOR THE PROPOSED DECISION AND OTHER ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

Grants from the Small Grants Scheme are made three times per year. All applications for grants were considered by the relevant Portfolio Holder who received advice from the Community Grants Officer and other relevant officers as appropriate.

The decision on the following application for a **Community Chest Grant** was deferred:

Wickham Allotment Association – this group does not currently have any formal management processes in place but are working towards addressing this. The application will be reconsidered in the next round which will give the group the opportunity to consider how they wish to develop their organisation.

The decision on the following application for a Community Planning Grant was refused:

St. Giles Hill Residents Association – it was considered more appropriate for this organisation to be considered for funding through the Village Design Statement Budget held by Strategic Planning.
