- It is proposed to introduce 'Disabled Badge Holders Only' restrictions in Market Lane, Winchester to provide additional parking areas for disabled motorists in response to difficulties encountered due to the amended access hours for the High Street, Winchester.
- The proposal is in keeping with the Corporate Priorities in its attempt to improve traffic management, road safety and the environment.


