**SUMMARY**

- It is proposed to introduce 'no waiting at any time' restrictions at the junctions of Cathedral View/Highcliffe Road and Cathedral View/St Catherines Road, Winchester due to inconsiderate parking causing obstructions for emergency services vehicles and other large vehicles.

- The proposal is in keeping with the Corporate Priorities in its attempt to improve traffic management, road safety and the environment.
- No objections were received to the proposal.
- The cost of the proposal will be funded through the Traffic Management Agency Agreement with Hampshire County Council. There are no additional enforcement costs.

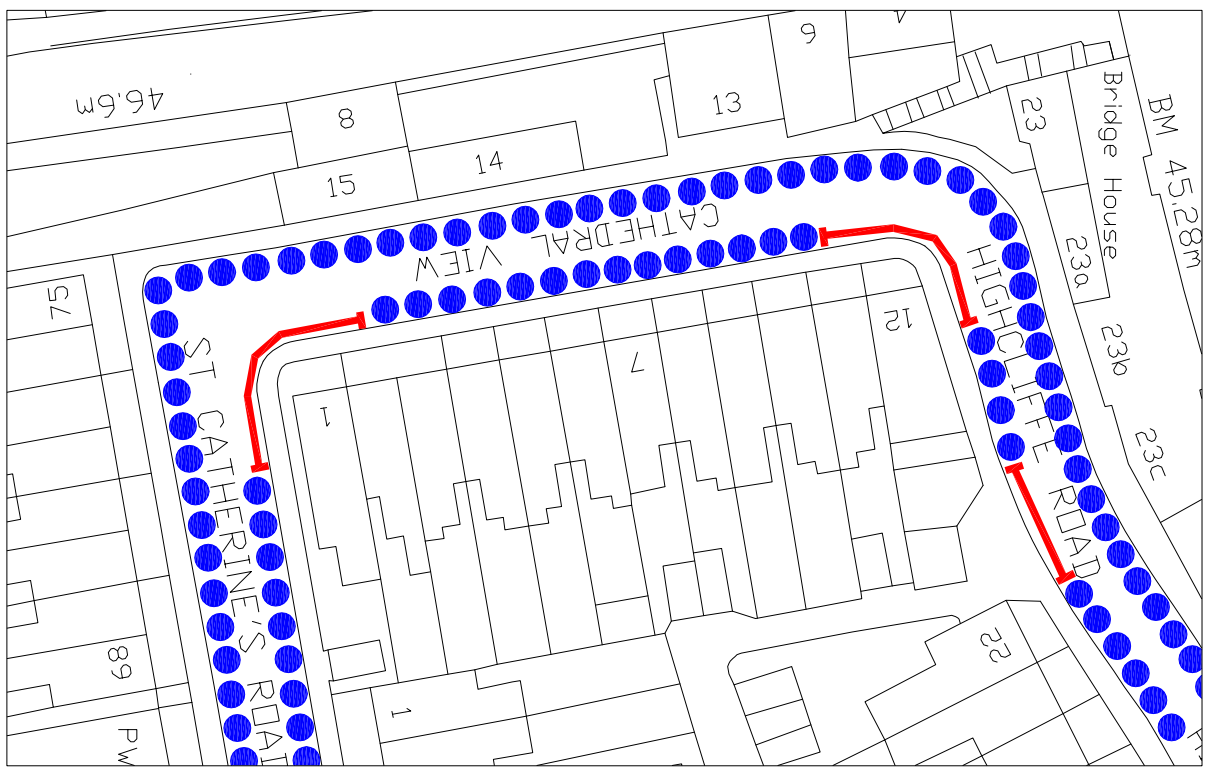

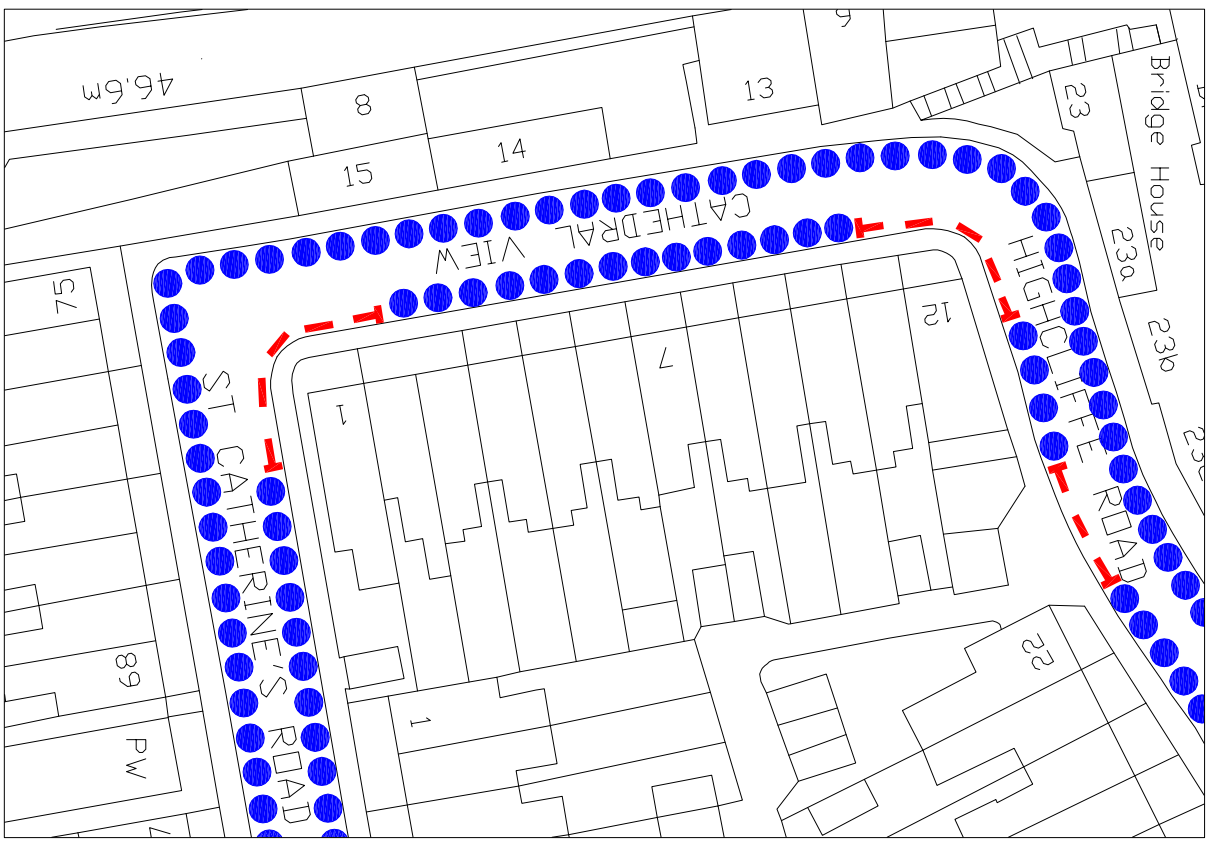
