Funding recommended towards helmets and overalls for volunteers based in the Winchester District.

**Community History Partnership of Winchester**

**Amount Requested: £500**

**Amount Awarded: £400**

Funding recommended towards the promotion of the activities of this new group.

**Curdrige Rainbows**

**Amount Requested: £500**

**Amount Awarded: £370**

Funding recommended towards the purchase of equipment for this newly formed group.

**North Winchester Youth & Community Action Group**

**Amount Requested: £495**

**Amount Awarded: £400**

Funding recommended towards the set-up costs of this newly formed group.

**Rainbow Playgroup**

**Amount Requested: £500**

**Amount Awarded: £370**

Funding recommended towards the purchase of new play equipment to encourage physical activity.

**Winchester Live at Home Scheme**

**Amount Requested: £464**

**Amount Awarded: £400**

Funding recommended towards the purchase of a laptop computer in order to offer computer training to elderly people in the District. This application was deferred from the previous round in order to consider whether this group could make use of the Council laptop loan scheme. However difficulties have arisen regarding licences and virus protection and therefore a grant is clearly needed to allow this activity to start up.

2. It is recommended that the following grants be awarded from the **Community Planning Scheme**:

**Greening Fulflood**  
**Amount Requested:** £494  
**Amount Awarded:** £494

Funding recommended towards the cost of holding meetings to launch the Greening Fulflood campaign and the production of 10 actions to reduce the carbon footprint of Fulflood.

**North Winchester Youth & Community Action Group**  
**Amount Requested:** £450  
**Amount Awarded:** £450

Funding recommended towards the cost of a public open day to enable a survey of local residents and families and to develop a community plan.

### **REASON FOR THE PROPOSED DECISION AND OTHER ALTERNATIVE OPTIONS CONSIDERED AND REJECTED**

Grants from the Small Grants Scheme are made four times per year. All applications for grants were considered by the relevant Portfolio Holder who received advice from the Partnership and External Funding Officer and other relevant officers as appropriate.

The decision on the following application for a **Community Chest Grant** was deferred:

**Alresford Town Partnership** – this application has been deferred in order that clarification can be sought as to which element of the project this group is seeking funding for and what other funding is already in place.

The decision on the following application for a **Community Chest Grant** was refused:

**National Childbirth Trust (Winchester)** – an application for funding towards the BABIES project has been refused as there is no evidence that they are targeting those areas that are most in need of this service and the organisation has insufficient funding in place to ensure the service will continue. The group will be contacted in order that discussions can take place with the Portfolio Holder for Communities and Safety, as well as appropriate WCC officers, as to the viability of the project and to assist them in identifying alternative funding sources for the BABIES project.
