SUMMARY

The 2008/09 Capital Programme makes budgetary provision for a range of high priority urgent works to operational properties (CAB 1559 refers).

Urgent works were identified to a number of sites including the Westgate Museum where a replacement roof covering and associated works are required.

WORKS PROCUREMENT UPDATE

In relation to this proposed project, Scheduled Ancient Monument Consent has been applied for and granted for the works. Detailed specifications and drawings have been produced and competitive tenders invited and received during October 2008. Chalke Valley Roofing have submitted the lowest tender and works are programmed

to commence as soon as practically possible, (subject to Contract and access arrangements) with a duration of approximately 6 weeks.

BUDGET

All works and associated fees are estimated and projected to come within the respective capital budgets of: -
