# **SUMMARY**

- It is proposed to introduce 'No waiting at any time' waiting restrictions in Hillier Way, Russell Road, Chaundler Road and Dyson Drive, Winchester and proposed to introduce 'No waiting 9am to 3pm, Monday to Saturday' on Chaundler Road to provide better visibility at each junction and to provide better access for buses.
- The revision has been requested by residents and Stagecoach Bus following road safety and emergency services and other access concerns.
- The proposal is in keeping with the Corporate Priorities in its attempt to improve traffic management and road safety.
- No objections to the proposal as advertised were received.

- The cost of the proposal will be funded through the Traffic Management Agency Agreement with Hampshire County Council. There will be no additional enforcement costs.




