**SUMMARY**

- It is proposed to introduce "No Waiting 10:00am to 4:00pm Monday to Friday" restrictions in Romsey Road (southern slip), Winchester due to inconsiderate and illegal parking causing obstructions.
- The proposal is in keeping with the Corporate Priorities in its attempt to improve traffic management, road safety and the environment.
- No objections to the proposal as advertised have been received. Two letters of support have been received.
- The cost of the proposal will be funded through the Traffic Management Agency Agreement with Hampshire County Council. There will be no additional enforcement costs.

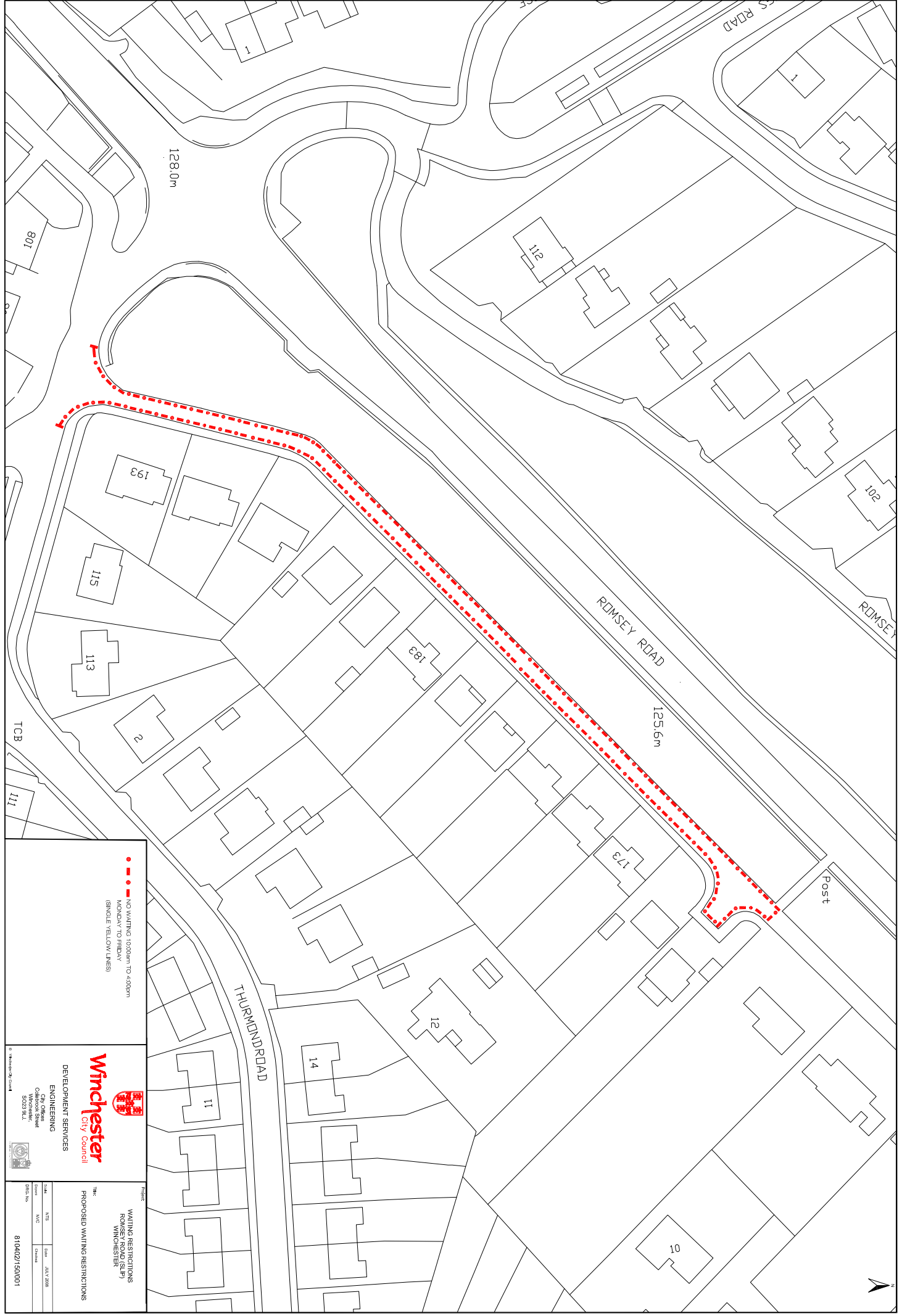
