SUMMARY

Approval is sought to the detailed Business Plan for this Division. The Business Plan sets out the key actions that the Division will undertake over the coming five year period, with SMART (Specific, Measurable, Agreed, Resourced and Timed) targets (both through actions and performance indicators) by which progress will measured and monitored. The Plan also gives additional information about the role of the Division, the resources allocated to it (in terms of both staff and budgets) and the key risks that are being addressed through its work.

- Progress Winchester High St refurbishment Scheme and associated vehicular restrictions.

The Head of Division is satisfied that the actions put forward in this Business Plan will work towards the Council's objectives, as set out in the Sustainable Community Strategy 2009-14 and Corporate Business Plan or otherwise ensure that the Council meets the statutory obligations put on it by central Government. Other than where indicated, these actions can be achieved within the resources available. Plans are in place, or will be developed, to ensure that targets shown for key performance indicators can be achieved in the timescales shown.

1. Brief Description of the Service and its Purpose

The Access and Infrastructure Division delivers the following services:

- traffic management
- transport planning advice and support for development of key projects
- on and off street parking control and management
- management of the Councils CCTV systems
- concessionary travel
- park and ride services from St Catherine's and Barfield car parks and South of Winchester from April 2010
- engineering advice, design and scheme delivery
- land drainage, river management, maintenance and improvement of the Council's Sewerage treatment works and street nameplates

Access and Infrastructure Division Business Plan 2009 - 2014

1 Brief Description of the Service and its Purpose

The Access and Infrastructure Division delivers the following services:

- traffic management
- transport planning advice and support for development of key projects
- on and off street parking control and management
- management of the Councils CCTV systems
- concessionary travel

- park and ride services from St Catherine's and Barfield car parks and South of Winchester from April 2010
- · engineering advice, design and scheme delivery
- land drainage, river management, maintenance and improvement of the Council's Sewerage treatment works and street nameplates
- community transport support

These service areas impact greatly on a wide range of the District's residents, employees, land owners and businesses.

Effective management of traffic and parking, transport planning, community transport, concessionary travel, street nameplate provision and the delivery of engineering schemes through joint working with the Hampshire County Council as Transport Authority is key to providing better services, safeguarding the environment, delivering Government and local policies and making communities safer and more inclusive.

Our land drainage, river management and sewerage responsibilities are critical, both, for residents and landowners and in respect of our environmental responsibilities.

3. Summary of Progress in 2008/09

1. Manage the Council's sewerage treatment works and implement agreed capital programme.

The treatment works are sampled monthly by the City Council and on an ongoing basis by the Environment Agency. The maintenance of the works and equipment is contracted out to specialist companies and overseen by City Council Staff.

There have been issues with the Widley Walk sewerage treatment plant discharge levels resulting in the issuing of a caution by the Environment Agency. Discussions have taken place with EA and works underway to reduce the risk of this happening in the future.

We have experienced problems with land and easement issues resulting in the deferment of schemes in the capital programme. The new programme for 2009/01 has now been agreed by Cabinet and reflects this slippage.

Notice has now been served on Southern Water in relation to adoption of works.

2. Work in partnership with the County Council to deliver the South of Winchester Park and Ride.

Throughout 2008 we have worked with the County Council on formulating the scheme design and progression having achieved the planning planning approval in the previous year. The scheme is due to start in April 2009.

Cabinet considered the scheme in February 2009 and a report will be taken to the May 2009 Cabinet meeting to agree bus routes/ services/ frequencies and charging details. The City Council are in negotiation with the County Council over the Lease for the new site.

3 Implement the National concessionary travel scheme (new free bus passes) from April 2008.

This was achieved and the scheme is now running on a National basis.

4. Implement revised car parking charges.

Revised car parking charges were introduced in April 2008

5. Undertake annual review of car parking charges

Revised parking charges were agreed by Cabinet in February 2009.

6 Reduce number of outstanding Traffic Regulation order requests

12 TROs have been introduced during the year and over 117 small scale schemes delivered.

7 Develop a Winchester Town Access Plan

The plan is progressing and a detailed first stage traffic management review has been completed which will be presented to members in April 2009.

8 Maintain engineering capacity and deliver programme of work

The Car park improvement programme was completed in full. Safer Route to school schemes have been completed and the Denmead Environmental Enhancement is substantially competed with the final landscaping work to be undertaken in March 2009. The Perins school design, planning and tendering process was completed and schemes for the St James Lane footpath, National Cycle Route Network 23 and Parchment St enhancement progressed..

9 Review the City Council's support for community transport

Joint work with WACA has continued, and in liaison with HCC, the City Council's annual grant has been distributed to voluntary groups. A consultation was completed for the new Rural Transport Grant and grants allocated. The Winchester Dial a Ride scheme was also tendered as was the Wheels to Work Scheme..

10 Provide advice on drainage and flooding issues

Advice has been provided as required.

11. CCTV

The monitoring contract was re-tendered and let in 2008 and has been working well. The project to relocate and upgrade the current control room and CCTV system has now begun with Notices placed in March 2009..

12. Winchester High Street Refurbishment

The scheme was tendered in December 2008 to appoint a contractor under the Early Contractor involvement scheme. The Traffic Regulation Order changes to the High Street will be implemented in April 2009.

13. Preparation for introduction of Traffic Management Act parking regulations. This was fully achieved.

14. Run parking service, park and ride, enforcement teams to meet agreed targets and actions.

Achieved in full with many new initiatives introduced including motorcycle enforcement, park mark accreditation, many improvements to car parks and management of works at Tower Street and Jewry Street car parks.
