SUMMARY

- It is proposed to introduce 'No waiting at any time' waiting restrictions in Trussell Crescent and Fromond Road, Winchester at their southern junction to provide better visibility at the exit of Trussell Crescent onto Fromond Road with the introduction of one-way traffic in Trussell Crescent.
- The revision has been requested by residents following road safety and emergency services and other access concerns.
- The proposal is in keeping with the Corporate Priorities in its attempt to improve traffic management and road safety.
- No objections to the proposal as advertised were received.
- The cost of the proposal will be funded through the Traffic Management Agency Agreement with Hampshire County Council. There will be no additional enforcement costs.
