# <u>TOPIC – PROPOSED REVISION TO TRAFFIC REGULATION ORDER – COLEBROOK STREET, WINCHESTER</u>

### **SUMMARY**

- It is proposed to revise the existing traffic regulation order in relation to waiting restrictions in Colebrook Street, Winchester from the existing restriction of 'Permit Holders Only 8:00am to 10:00pm Monday to Saturday' to 'Disabled Permit Holders Only' for the two existing unenforceable disabled bays marked opposite 109-111 Colebrook Street.
- The revision has been requested by residents due to the existing unenforceable disabled bays being used by non-blue badge holders.
- The proposal is in keeping with the Corporate Priorities in its attempt to improve social inclusion.
- Six letters of objection and one letter of support, with three additional signatures of support, were received to the proposal as advertised.
- After discussions with one of the local Ward Members it has been established that
  the existing unenforceable disabled bay marked adjacent to The White House,
  Colebrook Street is no longer required. The proposal has therefore been amended to
  include only the two bays opposite 109-111 Colebrook Street. All correspondents
  have been notified of this revision to the proposal.

 The bay adjacent to The White House, Colebrook Street will be removed in due course.

 The cost of the proposal will be funded through the Traffic Management Agency Agreement with Hampshire County Council. There will be no additional enforcement costs.

#### PROPOSED DECISION

It is recommended that;

1. Waiting restrictions for the two unenforceable disabled bays opposite 109-111 Colebrook Street be revised to 'Disabled Permit Holders Only' as advertised and the City Secretary and Solicitor be authorized to make the necessary order.

2. The unenforceable disabled bay adjacent to The White House, Colebrook Street is to be removed and the existing waiting restrictions of 'Permit Holders Only 8:00am to 10:00pm Monday to Saturday' are to remain unchanged.

# **Summary of Correspondents**

#### Objectors Summary of Reason for Objection

Miller 14 Colebrook Street Disproportionate to have 3 disabled bays

from a total of 22 bays in Colebrook Street. An enforceable disabled bay not being used will be worse than an unenforceable bay being

"abused" by some other residents.

Parking in Colebrook Street is a constant problem as unlike other streets there are no neighbouring streets which can be used to

park.

Overall sense that the Council is not sympathetic to residents problems – goes on to

suggest a number of possible options.

Chin-Wolf 26 Colebrook Street Disabled drivers have more options than able-

bodied residents. Proposal to make the 3 advisory bays compulsory will leave only 18

bays for residents/visitors.

Situation made more difficult due to Colebrook Street car park being full during certain times

of the day and night.

Wants a meeting to discuss other parking

options.

Simon 25 Colebrook Street Will greatly increase the pressure on the

already over-stretched residents parking spaces in Colebrook Street. Represents an unusually high ratio of disabled spaces to standard bays in such a small area (approx 20 spaces in total)

Already insufficient space in Colebrook Street for residents and resulting pressure. Although in Zone S the other streets in this zone are a long

way away.

Bays that used to offer an hour's free parking are now pay and display, further removing the small

amount of flexibility these offered.

Existing restrictions not enforced after 6pm

leading to non-residents using bays.

Disabled permit holders often park in residents bays when they could park on the single yellow lines, thus keeping residents bays available for residents.

Harding 17 Colebrook Street

This would mean 3 out of 21 parking spaces in Colebrook Street would be for disabled drivers which is out of proportion to the number of disabled/able-bodied residents.

Already ample provision for visiting disabled drivers.

Already severe pressure on the available parking spaces as not only residents cars but also nearest available parking for Friends Meeting House and Emmanuel Church.

Colebrook Street is separated from the rest of Zone S.

Wants a meeting to discuss other parking options.

McCabe 104 Colebrook Street

Lack of spaces for 'permanent residents' of Colebrook Street.

Abuse of visitors parking permits by commuters.

Exaggeration of the issue concerning abuse of the existing advisory disabled bays.

Davies 19 Colebrook Street

Proposal to make 3 bays enforceable would Mean that over 14% of bays in Colebrook Street would be for disabled use.

Colebrook Street is separated from the rest of Zone S.

Already ample provision for visiting disabled drivers locally.

Strain on residents already such that residents are forced to cruise for extended periods to find a free parking space adding to congestion and pollution.

Wants a meeting to discuss other parking options.
