SUMMARY

- It is proposed to revise the existing traffic regulation order in relation to waiting restrictions in Bereweeke Road, Winchester to relocate the existing 'No Time Limit' parking bays.
- The revision is necessary due to the development of the new day centre in Bereweeke Road. The existing parking bays are directly opposite the new site entrance and could cause road safety and access problems if they were to remain.
- Informal consultation had been undertaken with Councillors and residents in the immediate vicinity and the proposal is the result of this consultation.
- The proposal is in keeping with the Corporate Priorities in its attempt to improve the environment.
- No objections to the proposal as advertised were received.


