- It is proposed to revise the existing traffic regulation order in relation to waiting restrictions in Hatherley Road, Winchester from the existing restriction of 'Permit Holders Only 8:00am to 6:00pm Monday to Saturday' to 'No Waiting At Any Time' to ensure clear access for a proposed new development.
- The revision is being progressed in anticipation of a planning application.
