#### **SUMMARY**

The Community Safety Partnership has been allocated the sum of £8,200 as grant funding from Hampshire County Council. The criteria outlined for expenditure includes the delivery of local initiatives that will have a positive impact on the wider Hampshire priorities.

The Police & Crime Commissioner is due to be elected on 15 November 2012 and the successful candidate will hold the budget for crime & disorder reduction from April 2013. For the interim period the funding for 2012 -13 has been allocated to districts and boroughs as an extension of last year's agreement with the County. The allocations were agreed as set out in a report to the County Strategy Group on 20 September 2011.

The CSP plan to use the funding to deliver on the following local crime & disorder priorities:

- **Reducing Crime** Violence with Injury (DV, NTE), burglary, drug dealing)
- Tackling Disorder ASB (rowdy & nuisance behaviour), criminal damage
- **Responding to Community Concerns** Focusing on Speeding, Environmental issues and Rural Crime

## PROPOSED DECISION

That the Portfolio Holder for Communities, Culture & Sport approves the proposed expenditure of £8,200 (funding allocation) for the delivery of the CSP priorities 2012/13 (see Appendix 1).

## REASON FOR THE **PROPOSED** DECISION AND OTHER ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

The County Council is the beneficiary of an overall amount of Government Community Safety Funding for 2012/13. They have agreed to passport a proportion of those funds to Districts and Boroughs across Hampshire for use in the delivery of priorities that contribute to Hampshire wide crime & disorder reduction. In line with Government commitments this money is not ring-fenced. However, any decision to use it for other purposes would mean that Winchester CSP would be unable to deliver initiatives which will assist in achieving both the Winchester and County Crime Reduction Targets. It will also harm partnership working in this area of work.

The relevant budgets for income and for Expenditure to be increased in 2012/13 by  $\pounds 8,200$ .
