#### <u>TOPIC - REDUCTION OF WAITING RESTRICTIONS, NORTH ROAD, KINGS</u> WORTHY

#### **SUMMARY**

- To assist the creation of a new parking area in North Road by the Housing Estates Improvement Team, a reduction of the existing double yellow lines were proposed.
- Two new lay-bys are being created out of existing verge land, creating six parking spaces. An existing lamp column in the verge has prevented the parking area from being one long lay-by and therefore has split the area into two, allowing the streetlight to remain in situ. The double yellow lines were proposed to be removed from this area to allow vehicles to park in the new lay-bys.
- The proposal is in keeping with the Corporate Priorities in its attempt to improve traffic management, road safety and the environment.
- No letters of objections were received to the proposal.

- The cost of the proposal will be funded through the Traffic Management Agency Agreement with Hampshire County Council. There are no additional enforcement costs.



Winchester City Council acting on behalf of Hampshire County Council in exercise of its powers under sections under Sections 1,2 4,32,35,45,46,49,51 and 53 of the Road Traffic Regulation Act 1984 ("the Act"), as amended by the Road Traffic Regulation (Parking) Act 1986, Part IV of Schedule 9 to the Act , and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following order:
