## **TOPIC - GRANTS FOR APPRENTICES – UPDATE TO SCHEME**

## **SUMMARY**

- The minutes of Cabinet on 8 February 2012 state under item 11 Core Grant Allocations for 2012/13 (Report <u>WTF164</u> and <u>Addendum</u> refers): "4. The proposed allocation of £10,000 as a new fund to incentivise apprenticeships be approved, subject to the approval of the detail of the scheme through the Portfolio Holder Decision Notice process;"
- The Portfolio Holder Decision notice <u>PHD390</u> sets out the detail of the grant scheme, including the criteria and application process.
- This Portfolio Holder Decision notice sets out to amend the original grant scheme criteria that were approved in PHD390. The original grant criteria

give the applicant the opportunity to claim a maximum grant of £1,000, of which up to £400 could be for transport costs to the workplace and/or training location. All the applications and enquires the Economy and Arts team have received are for the full £1,000 towards transport costs. The Winchester District is predominately rural and young people starting out on an apprenticeship need help with costs for travelling to work.

- This Portfolio Decision Notice seeks to increase the amount an applicant can claim for costs of travel to work from £400 to £1,000.
- This work directly supports the Economic Prosperity theme and the overarching priority of Access to Services in the sustainable community strategy.
- The total allocated for this Scheme in 2012/13 is £10,000.
- It should noted that this decision does not relate to approval of the scheme itself, but covers the criteria which will govern the Scheme, as set out in <u>PHD390</u>

### PROPOSED DECISION

- 1. That the criteria for the Grants for Apprentices Scheme set out at the Appendices to the Notice be amended so that applicants can claim a maximum £1,000 towards the costs of travelling to the work place and/or training venue.
- 2. That the Head of Economy and Arts be authorised to implement the scheme with immediate effect, based on these criteria.

## REASON FOR THE **PROPOSED** DECISION AND OTHER ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

This scheme must adhere to a set of approved criteria to ensure that it is equitable and effective. As is made clear earlier in this Decision Notice, the proposed changes are a result of the demand for the grant scheme to date, responding to local need.

#### **RESOURCE IMPLICATIONS:**

£10,000 was allocated in the 2012/13 budget which was approved by the Council on 23 February 2012.
