<u>TOPIC – TRAFFIC REGULATION ORDER - ANDOVER ROAD, WINCHESTER</u>

SUMMARY

- As part of a proposed controlled pedestrian crossing for Andover Road,
 Winchester it is necessary to remove a small section of the existing 'Pay and
 Display 1 hour Limited Waiting with Permit Holders Exemption Monday to
 Saturday 8:00am to 6:00pm' parking bay and replace it with 'no waiting at any
 time' double yellow line restrictions. It is possible to mitigate this by introducing an
 additional section of parking bay further along Andover Road at the redundant
 entrance to the Cattle Market car park.
- The proposed changes were advertised on 10 October 2012. The notice was published in the Mid Hants Observer, posted on site and placed on deposit. Letters and plans were also sent to properties in the immediate vicinity.

- The proposal is in keeping with the Corporate Priorities in its attempt to improve traffic management, road safety and the environment.
- No letters of objections were received to the proposals.
- The cost of the proposal will be funded through the Traffic Management Agency Agreement with Hampshire County Council. There are no additional enforcement costs.
- Copy of the plan showing the location of the proposal is attached (Appendix 1).
- Copy of proposed schedule and a statement of reasons is attached (Appendix 2).
- Copy of the proposal notice is attached (Appendix 3).
- Copy of the advertised order is attached (Appendix 4).


The cost of advertising and implementing the traffic regulation order is covered by the Traffic Management agreement with Hampshire County Council.
