# PROPOSED INDIVIDUAL DECISION BY THE PORTFOLIO HOLDER FOR COMMUNITIES, CULTURE AND SPORT

#### TOPIC - EMERGENCY PROJECT GRANT - MEON HALL, MEONSTOKE

### PROCEDURAL INFORMATION

The Access to Information Procedure Rules – Part 4, Section 22 of the Council's Constitution provides for a decision to be made by an individual member of Cabinet.

#### **SUMMARY**

- A formal request has been received for an Emergency Project Grant of £1,200 from Winchester City Council to carry out essential repairs to the blocked foul drain pipes at the Meon Hall, Meonstoke.
- Basic annual maintenance is carried out to the foul drain system. However, the latest checks, including a professional survey, revealed a serious blockage arising from an 85% infestation of tree roots in one pipe, around 5 metres in length.
- Without urgent works to the pipe, the hall is threatened with closure on health and safety grounds.

- The Hall Committee has been given two options, a cheaper one for a short term, local solution and a more expensive one for full remedial works.
- The Portfolio Holder believes that it would be better to support full remedial work, the full cost of which is £4,800.
- The Hall Committee has already secured funding from two parish councils to support this grant request. This is in keeping with the principles of the Activity Community Project Grant Programme.
- It is proposed that the Council award an Emergency Project Grant of £1,200. The Resources section below sets out the full list of contributions, making up the total cost of the works.
- The Portfolio Holder is aware that the Meon Hall Management Committee has a consistent record of securing Council grants, including a Project Grant in 2011/12 for £1,800. Taking this into account, she proposes a condition that they receive no further project funding in 2013/14.
- This award is in keeping with the Active Communities Outcome, which sets the framework for all Community Grants Programmes.

## **PROPOSED** DECISION

- 1. That an Emergency Project Grant of £1,200 be awarded from the Grants Reserve to the Meon Hall Management Committee for urgent repairs to blocked foul drain pipes.
- 2. That this grant be awarded on the understanding that the Management Committee will not be awarded a further Active Communities Project Grant in 2013/14.

# REASON FOR THE PROPOSED DECISION AND OTHER ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

As indicated above, the Portfolio Holder considered the option of a smaller contribution for a temporary repair, but decided that a full repair would represent a better use of Council funds, with a longer-term impact.

#### **RESOURCE IMPLICATIONS:**

Winchester City Council maintains an earmarked Grants Reserve to ensure that emergency grant requests of this nature can be supported. The balance on the earmarked grant reserve currently stands at £12,550.

It is proposed to allocate £1,200 from this Reserve to this project. The other contributions to make up the total of £4,800 are set out in the table below.
