<u>TOPIC - TRAFFIC REGULATION ORDER - ANDOVER ROAD, MICHELDEVER</u> STATION

SUMMARY

- Due to regular problems with heavy goods vehicles attempting to negotiate the bridge at Andover Road, Micheldever Station and regularly getting stuck on the tight bend a request was received from the local Parish, City and County Councillors for additional restrictions to be introduced.
- During investigations into the existing width restriction order made in 1973 it was
 evident that the existing order was unenforceable due to the wording of the
 description. A new Order was therefore drafted to ensure the proposed
 restrictions can be suitably enforced in future.
- The proposed restrictions are for both a 6 foot 6 inch/2.0 metres width limit and a 7.5 tonne weight limit to be introduced. The restrictions are to have no exception for access.

- The proposed changes were advertised on 12th December 2012. The notice was published in the Mid Hants Observer, posted on site and placed on deposit.
- The proposal is in keeping with the Corporate Priorities in its attempt to improve traffic management, road safety and the environment.
- No letters of objections were received to the proposals.
- The cost of the proposal will be funded through the Traffic Management Agency Agreement with Hampshire County Council. There are no additional enforcement costs.
- Copy of the plan showing the location of the proposal is attached (Appendix 1).
- Copy of proposed schedule and a statement of reasons is attached (Appendix 2).
- Copy of the proposal notice is attached (Appendix 3).
- Copy of the advertised order is attached (Appendix 4).

DECISION

- 1. It is recommended to introduce revised restrictions as detailed in the schedule attached. (Appendix 2)
- 2. That the Head of Legal Services be authorised to make the necessary order.



Winchester City Council acting on behalf of Hampshire County Council in exercise of its powers under sections under Sections 1,2 4,32,35,45,46,49,51 and 53 of the Road Traffic Regulation Act 1984 ("the Act"), as amended by the Road Traffic Regulation (Parking) Act 1986, Part IV of Schedule 9 to the Act , and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following order:-

- In this order the "Principal Order " means "The Hampshire (Micheldever Station)
 (Width restriction) Order 1973" as amended.
- 2. The Principal Order shall have effect in that the items in Schedule I to this order shall be inserted into the Schedule of the Principal Order and article 1. of the Principal Order shall be amended as detailed in Schedule 2 of this order
 - This order may be cited as The Hampshire (Micheldever Station)(Width restriction) Order 1973 (Variation No. 1) Order 2012 shall come into operation on the day of 2012

SCHEDULE 2

1. Save as provided in Article 2 of this Order no person shall except upon the direction of a police officer in uniform or traffic warden cause or permit any vehicle, the width of which, inclusive of any load on the vehicle, exceeds 6ft. 6 inches (2.0metres) to proceed in the length of Road as specified in the Schedule to this Order and no person shall except upon the direction of a police officer in uniform or traffic warden cause or permit any vehicle exceeding a gross weight of 7.5 tonnes to proceed in the lengths of Road specified in part A of the Schedule to this Order
