TOPIC - MARKET TOWNS DEVELOPMENT

SUMMARY

- The past year has seen the creation of a 'Town Team' in Bishop's Waltham, in response to the recommendations in the Government's review of high streets led by Mary Portas.
- The Town Team includes representatives of the Chamber of Trade, the Parish Council, Bishop's Waltham Society, Bishop's Waltham in Bloom, and Winchester City Council.
- Although The Team failed in its bid to the Department of Communities and Local Government to become a Mary Portas Pilot (attracting a £100,000 grant), The Town Team was awarded £10,000 last autumn to become a

Portas Town Team Partner, with backing from MP George Hollingbery. Winchester City Council holds these funds on the Town Team's behalf.

- Based on the consultation carried out locally, the Town Team decided to
 use this money to employ a part-time Market Towns Development Officer
 on a two day per week basis in order to deliver an agreed action plan to
 strengthen the resilience and success of the town centre ready for the
 advent of the new Sainsbury's store.
- The Parish Council has agreed to match the Government grant for two financial years from 2013/14. The Portfolio Holder for Economic Development has indicated his support for the City Council to do likewise (such funding to come from the Economic Development base budget).
- Winchester City Council invited other market towns (Denmead, Wickham and Alresford) to participate in the initiative to make best use of its investment of funds and staff time. Denmead and Wickham Parish Councils have both decided to pay for one day a week each for the post, over the same, two-year period.
- Following consultation with the Portfolio Holder, the Head of
 Organisational Development and the Corporate Management Team
 approved the appointment by the Council of the Development Officer on a
 one year contract, with potential to extend to a second year if it is a
 success. The post reports to the Head of Economy and Arts, but will work
 with a steering group in each of the three towns/villages to ensure that the
 work which is delivered is what is required locally.
- The initiative directly supports the Economic Prosperity outcome of the Winchester District Community Strategy. Although most economic development activity is designed to support businesses across the Winchester District, Member feedback to officers suggests a desire to see more done to support very directly the business communities of the District's rural areas.

PROPOSED DECISION

That:-

- a) the decision that Winchester City Council act as the employer for the shared Market Towns Development Officer post, for a maximum two year period, be endorsed; and
- b) the Assistant Director (Economy and Communities) be authorised to establish a five-way funding programme (as shown in the resources section below) to pay for the employment of the above Post.

REASON FOR THE PROPOSED DECISION AND OTHER ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

The decision to appoint a Market Towns Development Officer was based on extensive consultation in Bishop's Waltham, which led to the creation of a local action plan which there was no capacity to deliver. At the time, the Chamber of Trade was on the verge of cessation, and the business community was extremely worried about the impact this would have on the established programme of town centre events. Although the Chamber has since been revived, the Town Team sees the value of a professional who can support marketing, research, new events and other initiatives which will add value to the services delivered by the Chamber and Parish Council.

In Wickham, local traders were consulted about the desirability of such a post and were very much in favour. The proposal led to an offer of some seed-funding for the post-holder from the local Co-op, and the decision by traders to re-establish the defunct Chamber of Trade.

In Denmead, where a Neighbourhood Plan is currently being drawn up, the Parish Council saw the value of a resource which could help to establish a strong network of businesses locally, providing a clear voice for business need and helping to galvanise efforts to promote the local economy.

Although the Economy and Arts Team does work with all three communities, there was a consistent view that a dedicated post, based locally and focussed exclusively on the development of the three centres, would be the best means to deliver specific local objectives.

Advice has been sought from the Head of Organisational Development about the proposal for Winchester City Council to employ the post. No other organisation involved in the partnership currently has the resources to employ this officer, and although the Town Team did consider setting up as a limited company in order to do so, members of the Town team agreed that this would divert energy from delivery of their action plan.

RESOURCE IMPLICATIONS:

The Portfolio Holder for Economic Development has already supported the use of monies from the Economic Development base budget over two financial years to cofund the Town Team initiative.

The expenditure plan and five-way funding partnership contributions are set out below:

This sum is enough to fund the salary and on-costs of the 0.8 FTE grade 4 post which has now been appointed.

CONSULTATION UNDERTAKEN ON THE PROPOSED DECISION

- In March 2012 local consultation events took place in Bishop's Waltham to help form the Mary Portas bid. The Town Team had strong local support with 18 letters of support from local groups..
- The Economy and Arts Development Manager attended a business breakfast for businesses in Denmead to consult them on the proposal, and the Assistant Director for Economic Prosperity attended a meeting of businesses and parish representatives in Wickham for the same purpose.
- New Alresford Town Council was also approached on several occasions, but has decided not to take part on this occasion. They feel that the Chamber of Commerce is very active, and that the Town Council would struggle to justify additional funding to benefit the business community.
