#### **SUMMARY**

- Changes to the waiting restrictions in Hatherley Road, Winchester were requested by the developer of the former Nethercliffe School site to facilitate the new entrance to the new development in accordance with the planning application. As part of the changes it was established that additional on-street residents permit parking could be introduced giving a net gain in parking provision for residents.
- The proposed changes were advertised on 9 July 2014. Notices were posted on street in the immediate vicinity of the proposed changes, published in the Mid Hants Observer, placed on the Council's website and held on deposit in the City Office reception. No responses were received.
- The proposal is in keeping with the Corporate Priorities in its attempt to improve traffic management, road safety and the environment.

- The cost of implementing the proposal is funded by the developer. There will be no discernable additional enforcement costs.
- Copy of the plan showing the location and extent of the proposal is attached (Appendix 1).
- Copy of proposed schedule and statement of reasons is attached (Appendix 2).
- Copy of the proposal notice is attached (Appendix 3).


