SUMMARY

- Erskine Road and Peninsula Road, Winchester are owned by A2 Dominion Housing. Under an agreement between A2 and Winchester City Council these roads were included in the Council's Controlled Parking Zone (CPZ) Order and parking and waiting restrictions are enforced by the Council.
- As part of a major reconstruction exercise A2 are making significant changes to the road layout including changes to the parking and waiting restrictions. To make these changes enforceable would need a corresponding change to the CPZ Order, however A2 consulted their residents on these changes and established that they would rather opt out of the existing arrangement.

Consequently the Council has agreed to withdraw Erskine Road and Peninsula Road, Winchester from the CPZ Order. All future parking and waiting enforcement will be carried out directly by A2. Parking permit holders will receive a refund from the parking office in line with current policy.

- The proposed changes were advertised on 6 August 2014. Notices were posted on street in the immediate vicinity of the proposed changes, published in the Mid Hants Observer, placed on the Council's website and held on deposit in the City Office reception. No responses were received.
- The proposal is in keeping with the Corporate Priorities in its attempt to improve traffic management, road safety and the environment.
- The cost of implementing the proposal is funded by A2. There will be no future enforcement costs for the Council.


