SUMMARY

- Changes to the waiting restrictions in West Street, Alresford were requested by Hampshire County Council as part of their junction improvement works at West Street/Jacklyns Lane. The works include changing the kerb alignment at the junction as well as the removal of the existing service road on the southern side of West Street and corresponding kerb realignment along West Street. The changes will accommodate revised parking bays which require a variation to the existing Traffic Regulation Order (TRO).
- The proposed changes to the TRO were advertised on 5 November 2014.
 Notices were posted on street in the immediate vicinity of the proposed changes, published in the Mid Hants Observer, placed on the Council's website and held on deposit in the City Office reception. No responses were received.

- The proposal is in keeping with the Corporate Priorities in its attempt to improve traffic management, road safety and the environment.
- The cost of implementing the proposal is funded by HCC. The will be no additional enforcement costs.
- Copy of the plan showing the location and extent of the proposal is attached (Appendix 1).
- Copy of the proposed schedule and statement of reasons is attached (Appendix 2).
- Copy of the proposal notice is attached (Appendix 3).



Winchester City Council acting on behalf of Hampshire County Council in exercise of its powers under sections under Sections 1,2 4,32,35,45,46,49,51 and 53 of the Road Traffic Regulation Act 1984 ("the Act"), as amended by the Road Traffic Regulation (Parking) Act 1986, Part IV of Schedule 9 to the Act, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following order:-
