## **SUMMARY**

The Central Winchester Regeneration Informal Policy Group agreed at their <u>meeting</u> <u>18 October 2016</u> to commission technical work to inform the development of the Supplementary Planning Document (SPD) for the Central Winchester Study Area. A Portfolio Holder Decision Notice (PHD) is therefore required to authorise the commissioning of this work.

Full details of the Studies are set out in Appendix 1 to the Decision Notice.

## **Resource Implications**

It is estimated that the combined cost of these studies will be around £70,000, which will be funded from the Central Winchester Regeneration project budget.

## PROPOSED DECISION

That the Assistant Director (Policy and Planning) in consultation with the Portfolio Holder for Finance and Corporate Policy, be authorised to commission the technical studies listed below using the funds necessary within the Central Winchester Regeneration SPD budget, to inform the development of the Central Winchester Regeneration SPD.

- the Flood Risk Assessment
- Contamination Desk Study, Site Walk over and Conceptual Site Model
- Bus Provision/Need Assessment
- Retail Needs Assessment
- Archaeology Desk Study
- Topographical Survey
- Acoustic study/ assessment
- Lighting assessment
- Ecological

The authorisation above shall include the determination of the evaluation model to be used, (subject to consultation with the Portfolio Holder for Finance and Corporate Policy and the members of the IPG) the brief for the work, and selection of the consultant to be used.

## REASON FOR THE **PROPOSED** DECISION AND OTHER ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

In order to produce a robust SPD which is underpinned by a suitable evidence base, a number of technical studies are required.

Officers with expertise in the relevant areas have discussed the requirements for the SPD with the Project Team and identified the following studies that would be required for this level of planning document.

In addition to these studies, assessments will be undertaken by the organisation commissioned to formulate the SPD and carry out the public engagement. The brief for this work is currently being advertised on the SE Business Portal and Contract Finder and includes the requirement to provide the following assessments: consideration of views, character study, commercial aspects and valuation tests, consideration of accessibility and public realm issues.

There are also a number of existing studies which will inform the development of the SPD (Car Parking Strategy Mid-Term Review, HCC-led Winchester City Transport Strategy as well as existing studies which are not considered to need updates for the SPD (Economic Strategy; Cultural Strategy; Walking, Cycling and Parking Strategies etc.).

#### Alternative options taken into consideration

The requirement for the new technical studies follows the confirmation that the Council does not own the copyright for the supporting documents submitted as part of the previous planning applications on the site and therefore Councillors cannot rely on these documents when making any decisions.

Officers within the Council can assist in providing relevant information to any consultants commissioned, but do not have the resources to carry out these studies in-house within the necessary timescales for the SPD which is due to be adopted by the end of 2017.

The IPG members, CMT, Ward Members and the Portfolio Holder for Built Environment have been consulted on the proposed PHD Decision.
