

This also includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992, Section 52.



*NOTE: A body in which you or your partner have a beneficial interest means a firm in which you or your partner is a partner, or a body corporate of which you or your partner is a director, or in the securities of which you or your partner has a beneficial interest.*


