DBS DECLARATION:-

I understand that once I have received the Enhanced Disclosure issued by the Disclosure and Barring Service, I will contact the Licensing Section, Winchester City Council to arrange for a Licensing Officer to inspect it. I am aware that failure to show the Enhanced Disclosure to a Licensing Officer will result in my current application being refused or my current hackney carriage and/or private hire driver's licence not being renewed.

In the case of a current licensed driver, a two month badge has been issued to allow time for the Enhanced Disclosure to be received and inspected by a Licensing Officer. If the Licensing Section has not inspected your Enhanced Disclosure by the expiry date of the badge, your licence will not be extended and you will no longer be licensed to drive a hackney carriage or private hire vehicle.

CRIMINAL CONVICTIONS, CAUTIONS OR REPRIMANDS DECLARATION:-

I confirm that I have read and understood the application form for a licence to drive a hackney carriage and/or private hire vehicle. I understand that the Rehabilitation of Offenders Act 1974 does not apply and, if applicable, I have declared any convictions, cautions or reprimands.

INFORMATION FOR ALL APPLICANTS

DBS Check

An Enhanced Disclosure and Barring Service (DBS)* check is required which must be completed at the Council offices and countersigned by a Licensing Officer. The fee is £44 and is payable to Winchester City Council at the same time as the application fee. DBS checks are required initially and then every three years.

DBS Update Service

The DBS provide a scheme called the 'Update Service'. Applicants can make a one off DBS application and all subsequent checks (providing there are no changes to your criminal record) can then be made online by a Licensing Officer, with the applicant's permission. To sign up to the scheme please go to: https://www.gov.uk/government/organisations/disclosure-and-barring-service. The fee is £13 per year. You can only sign up to the scheme once an application has been made.

DVLA Check

All driving licences are checked through the DVLA and will require a mandate to be signed by you. Current drivers will have their driving licences checked every three years at the same time as the DBS check. This will be included within your licence fee. If you refuse to sign the mandate, a hackney carriage and/or private hire drivers' licence will not be granted or renewed.

Medical

A Medical Certificate in the form provided by the Council should be completed by a Doctor at your registered practice/surgery, or you may obtain a copy of your medical history to pass to another Doctor who must certify they have seen your records. Any fee charged will be payable by the applicant. (A Medical Certificate is required initially and then every fifth year until 63, at 63 and 65 years old and annually thereafter.)

Diabetes

Where the applicant has been diagnosed with Diabetes Mellitus, other than treatment by diet only, applicants must provide on renewal of their hackney carriage and/or private hire driver licence, or every 12 months in the case of a driver with a 3 years driver licence (when a medical report is not due) confirmation that they meet the Group 2 medical standards of fitness to drive in the form prescribed by the Council. This must be signed by the applicant's registered GP or a diabetic consultant.

Certificate of Good Conduct

In addition, identification documents will be scanned and forwarded to the UK Border Agency at their request. Applicants who were not born in the UK and have not lived in the UK for more than 10 years will also be required to supply a certificate of good conduct from their embassy or home country. A licence will not be issued without this.

Licences can only be granted or renewed on production of a current valid driving licence and counterpart plus the correct fee.
