Adoption of Winchester District Local Plan Part 1 – Joint Core Strategy

Adoption Statement

In accordance with the Planning and Compulsory Purchase Act 2004, Regulation 26 of the Town and Country Planning (Local Planning) (England) Regulations 2012, and Regulation 16 of the Environmental Assessment of Plans and Programmes Regulations 2004, notice is hereby given that the South Downs National Park Authority and Winchester City Council adopted the Winchester District Local Plan Part 1 – Joint Core Strategy Development Plan Document on 19 and 20 March 2013 respectively.

The adopted Local Plan Part 1 included the Main Modifications recommended by the Inspector who carried out the independent examination of the Plan together with the Council's Further Modifications which were considered by the Inspector and subject to public consultation. The Main Modifications are set out in the Inspector's report, and the Council's Further Modifications are included in the document "Schedule of Further Modifications 12 November 2012".

The adopted Local Plan Part 1 covers the administrative area of Winchester District including the area of the South Downs National Park Authority that lies within the District. The Local Plan Part 1 sets out the spatial vision, objectives, development strategy and policies to enable the delivery of sustainable development and communities in Winchester District for the period 2011-2031. An application must be made (Section 113 (4)) no later than the end of a period of six weeks from the date of the adoption of this Local Plan Part 1 - Joint Core Strategy, i.e. by 1 May 2013.
