

Winchester District Local Plan Part 1 - Joint Core Strategy

Proposals Map Schedule of Changes

1. Introduction

1.1. This document sets out the proposed changes to the proposal map of the Winchester District Local Plan Review (Adopted 2006) (WDLPR) that will be implemented through the policies in the pre-submission Local Plan Part 1 – Joint Core Strategy. This document identifies:-
