The Biodiversity section of the document does not adequately cover the special requirements of green field developments in rural areas. It covers only the biodiversity within the proposed development site and does not recognise there may be a significant impact upon neighbouring areas. For instance the natural migrations and daily movements of small mammals and amphibians can be severely disrupted by any developments occurring across their regular paths. It is essential, therefore, that green space links are provided between developments so that wildlife is not contained within any one area.

The changes required in the SDP are:

Paragraph 5.31 add: "The biodiversity of sites, particularly in rural developments, needs to allow for the migration habits of amphibians and small mammals. Wildlife corridors, linking to open spaces in adjoining sites, and the positioning of gaps in any barriers will avoid major disruptions to the ecology."

A new Policy Guideline to be added (QS2(A)): "Ensure that open spaces are linked to neighbouring sites with wildlife corridors and that boundaries allow the free passage of small animals."
