

# **OPEN SPACE ASSESSMENT 2013**

## **BISHOP'S WALTHAM**

The open space standard for Winchester District, set out in Policy CP7 of Local Plan Part 1: Joint Core Strategy, derives from the City Council's 2008 *Open Space, Sports and Recreation Study.* It stands at **4 ha per thousand people**, compared with the 2006 Local Plan standard of 2.8 ha. The revised standard is broken down into 5 categories -

The latest population statistics for the market towns are set out in a 2011 background paper to the LDF, *Market Towns and Rural Area Development Strategy*. For the purposes of this assessment, the population of Bishop's Waltham is 6,835. Applying the new standards to this figure, and comparing them with measured existing provision, indicates whether there is a notional surplus or shortfall in the quantity of open space for each category. Map-based and on-site surveys were used to determine the accessibility, distribution and quality of open spaces in the settlement.

<sup>&</sup>lt;sup>1</sup> This definition differs from the 2006 Local Plan standard which required '*equipped playgrounds*, other opportunities for outdoor play and casual play space'. Accordingly, this assessment has measured only equipped playgrounds, BMX and skatepark parks and Multi Use Games Areas, but not 'other opportunities for outdoor play and casual play space' as this land is now included under category 3 (Informal Green Space) or category 5 (Parks, Sports & Recreation Grounds). The lower total area figure reflects this change.

# 1. Allotments

### <u>Quantity</u>

The standard requires a minimum quantity of allotment space of 1.367 ha. Information supplied by the parish council and the Council's GIS system reveals only one site (below) - a small **surplus** of 0.644 ha.

Despite this surplus, there are large waiting lists and a growing demand for more allotment spaces within the town. Consequently, an area of 1.13 ha has been identified for further allotment space by the parish council at West Hoe Farm on the east side of the town.

#### Access and Distribution

The allotments are easily accessible, but are confined to a single site on the far western edge of the settlement (Albany Road). Distribution is therefore poor and every effort should be made to acquire the site at West Hoe Farm.

#### <u>Quality</u>

The quality of the site at Albany Road is good.

# 2. Equipped Children's & Young People's Play Space

#### <u>Quantity</u>

The standard requires a minimum quantity of 3.42 ha within a 480m walk for toddlers and juniors, and a 650m walk for youth.

Measurements from the City Council's GIS maps (above) reveal a shortfall of 2.49 ha against the standard. The development at Pondside will add approximately 85 people to the town's population which will marginally increase the standard to 3.46 ha. There would, however, be 0.105 ha of new play areas provided on site, reducing the **shortfall** very slightly to 2.43 ha.

#### Access and Distribution

Despite the shortfall in space for children's play, the distribution is good with very few parts of the town more than the recommended 480m from a play area of some description. The single exception is Garfield Close on the northern edge of the town.

### <u>Quality</u>

The quality of play areas is good having benefitted for several years from input from the parish council's grounds staff and the City Council's Open Space Funding System.

# 3. Informal Green Space

Informal Green Space is defined in the 2008 Open Space Study as publicly accessible and useable open space which is not allocated for any other use, and is neither laid out nor managed for a specific function such as a play area, a park, a recreation or sports ground, a nature area or allotment.

#### <u>Quantity</u>

The standard requires a minimum of 5.47 ha and a site within 400m of every household. Measurements (below) show a **shortfall** of 3.11 ha.

Abbey Field (0.6 ha) is proposed to become publicly accessible informal green space in association with the new Sainsbury's development. This will increase the total area to 3.14 ha and reduce the shortfall to 2.33 ha.

#### Access and Distribution

Distribution of informal green space is concentrated toward the central area of the town, with significant gaps in provision both in the far west (west of The Avenue), and in the north-east (Rareridge Lane).

#### <u>Quality</u>

Most areas are maintained by the parish council's contractors and are of a high quality.

# 4. Natural Green Space

Natural Green Space is defined in the 2008 Open Space Study as publicly accessible woodland, wetland, grassland / heathland or meadow, i.e. spaces which have natural characteristics and wildlife value, but which are also available for public use and enjoyment.

#### <u>Quantity</u>

The standard requires at least 6.84 ha of natural green space to serve Bishop's Waltham. The area available (below) **exceeds** the minimum requirement by 19.08 ha.

An additional 'ecological enhancement area' of 1.29 ha is proposed for the Pondside development. This will increase the amount of natural green space to 27.21 ha, and the **surplus** to 20.37 ha.

#### Access and Distribution

Distribution is very good. No part of Bishop's Waltham is more than 700m from a natural green space.

#### <u>Quality</u>

The quality is good.

# 5. Parks, Sports & Recreation Grounds

#### Sports grounds

#### <u>Quantity</u>

According to the standard, there should be 10.25 ha of parks, sports and recreation grounds, of which half (5.13 ha) should be sports pitches. According to the measurements below, there is a **surplus** of 4.73 ha.

### Access and Distribution

Distribution is reasonably good with two major sports pitch areas at each end of the town serving the two main areas of more recent growth east and west of the historic central core. Consequently, most of the population lives within 650m of a sports pitch, although there is a gap covering the historic core.

### <u>Quality</u>

Quality is very good.

### Parks and Recreation Grounds

#### <u>Quantity</u>

The remainder of the standard requires 5.13 ha of parks and recreation grounds for the town. There is a **shortfall** of 1.03 ha.

#### Access and Distribution

Despite there being a shortfall in quantity, distribution is very good with no part of the town being further than 650m from a park or recreation ground.

#### <u>Quality</u>

Parks and recreation grounds are maintained by the parish council and are of a good quality.
