EXECUTIVE SUMMARY:

This report contains details of applications for capital grant aid in 2009/10 and recommends appropriate levels of support based on the policies and criteria currently in force and the availability of resources.

RECOMMENDATIONS:

That Cabinet, subject to Council approval of the 2009/10 budget provision:

- 1 Approves the allocation of £9,000 for the 2009/10 Community Chest grant programme.
- 2 Approves the following capital grants for 2009/10, subject to compliance with the conditions of grant currently in force and any additional conditions specified in Appendix 1:

REPORT OF HEAD OF PARTNERSHIPS AND COMMUNICATIONS

DETAIL:

- 1 Introduction
- 1.1 The purpose of this report is to present details of the community capital grant applications for 2009/10 and to recommend appropriate levels of support for each, as outlined in Appendix 1.
- 1.2 The original application forms and supporting documents are held in the Partnerships and Communications Division. Any Member wishing to study the forms prior to the meeting should contact the Partnership and External Funding Officer who will make the necessary arrangements.

2 <u>Resources</u>

- 2.1 The 2009/10 budget proposals recommend a reduced budget for capital grants from £80,000 to £65,000 (CAB1786).
- 2.2 There is an earmarked grant reserve which exists in order that emergency grant requests (both capital and revenue) can be supported. The balance on the earmarked grant reserve at 31 March 2008 was £64,591 and during 2008/09 £22,674 has been released from this reserve leaving a balance of £41,917 at 23 January 2009.
- 2.3 Eight applications for capital grant were received and the total amount of grant requested for 2009/10 was £85,600, which is in excess of the available budget. This report recommends grant awards totalling £46,000 for 2009/10.
- 2.4 The application from Winchester Dramatic Society (Chesil Theatre) requests a grant of £90,000 to be spread over 3 years. Consideration will be given to awarding further grants to this organisation in 2010-11 and 2011-12 should funds be available.

- 2.5 A sum of £9,000 is to be made available for the Community Chest Scheme in 2009/10. This will provide very small grants of up to £500 for one-off items of expenditure. In the five years since the Scheme was established, 181 grants have been awarded across a wide range of community and voluntary organisations.
- 2.6 A sum of £10,000 remains unallocated from the capital grant budget. Should this remain unallocated by the year end it will be added to the grant reserve.
- 3 Application Details
- 3.1 Details of all the applications received are shown in Appendix 1. Each project has been subject to a rigorous evaluation to assess the level of community benefit, compliance with the policies and criteria currently in force, the level of external funding already secured, and sustainability. The recommended grant levels reflect the results of these considerations.
- 3.2 Members are reminded that the maximum level of City Council grant aid available to each project is double the contribution from the local parish council or the Winchester Town Account. There is an exception where the tax base for the Parish is 150 or below, which does not apply to any of the applications received.
- 3.3 Three requests for capital grant have been received from groups within the Town Forum area.
- 3.4 Two applications have not been recommended for support:
 - (i) New Alresford Town Council (West Street Project) grant has not been awarded for this scheme as it is not eligible under the current criteria for capital grant. This project to be further evaluated and a report to be submitted to a future Cabinet.
 - (ii) Weeke Community Association This group was awarded a grant of £7,000 in 2006-2007 but due to lack of other funding have not been able to progress this work. They have now revised the project into phases and have requested an additional grant for this work. The request was refused as it was considered that this organisation already has grant to enable the first phase of work to go ahead. Once they have completed this phase then they will be encouraged to apply for grant to complete the later stages.

OTHER CONSIDERATIONS:

4 <u>CORPORATE STRATEGY (RELEVANCE TO)</u>:

- 4.1 The priority areas for capital grant funding are in line with the Winchester City Council Corporate Strategy 2008 - 2013, and the Winchester District Community Strategy (updated March 2007).
- 4.2 The community capital grants scheme helps address many of the Council's priorities for the District and in particular those under Health and Wellbeing, and Inclusive Societies.
- 4.3 The provision of grants to village halls and recreational facilities is authorised by S 19 Local Government (Miscellaneous Provisions) Act 1976. Theatres can be given grants under S145 Local Government Act 1972. Grants can be made in respect of buildings of historic interest under S57 Planning (Listed Buildings and Conservation Areas) Act 1990.

5 <u>RESOURCE IMPLICATIONS</u>:

- 5.1 The recommendations in this report demand a total capital commitment of £55,000, which is made up of £46,000 in capital grant awards, and the £9,000 set aside for Community Chest grants.
- 5.2 The proposed capital programme allocation for grants in 2009/10, which will be decided upon as part of the budget consideration taking place elsewhere on the agenda for this meeting, is £65,000. Detailed debate on the resource issues is included in Section 2 of this report.
