SUMMARY

Approval is sought to let a contract for consultancy services on behalf of the authorities involved in the Hampshire and Isle of Wight Improvement (HIOW) Group - Revenues and Benefits Project. There are a number of such contracts for HIOW shared service projects, with the work shared across the different authorities, and it is reasonable that Winchester plays a part in this project.

On Friday 25 January the HIOW Board met and approved the next stage of the Revenues & Benefits project. £65,000 of funding was released. The majority of the funding (£55,000) will be used to engage a revenues 'expert' to move ahead with collaboration on training, temporary staff, business rates & fraud work.

Procurement officers from Basingstoke and Fareham will prepare tender documentation which will be approved by the Project Board comprising of officers from Basingstoke & Deane, Fareham, Portsmouth, Winchester and the Improvement Director, HIOW LGA. The Head of Revenues will oversee the tender administration process which will be conducted in

accordance with Winchester's Contract Procedure Rules. Winchester will enter into the contact on behalf all authorities and will recover the funding from HIOW.

PROPOSED DECISION

That the Head of Revenues in consultation with Head of Financial Services be authorised to let a contract for consultancy services on behalf of the authorities involved in the Hampshire and Isle of Wight Improvement (HIOW) Group - Revenues and Benefits Project within the limit of the £65,000 HIOW funding provision.
