

PROPOSED NEW ORDER-

WINCHESTER CITY COUNCIL

ROAD TRAFFIC REGULATION ACT 1984

THE WINCHESTER CITY COUNCIL (A31 ALRESFORD ROAD, WINCHESTER) (TEMPORARY 40 MPH SPEED LIMIT) ORDER 2007

STATEMENT OF REASONS:-

The scheme is being proposed on traffic management and road safety grounds to allow for the introduction of temporary 40 mph speed limit in association with special events held at Matterley Estate.

The order shall apply only such times and to such extent as may be indicated by traffic signs provided, with the agreement of the Director of Environment (HCC) and Chief Officer of Police, for the purpose of facilitating the passage on any road of any class of traffic in connection with the holding of an event likely to attract large volumes of traffic.

ROADS TO BE SUBJECT TO 40 MPH:-

A31 ALRESFORD ROAD, WINCHESTER for a distance of 6.4 kilometres between its junction with the A272 Petersfield Road and the roundabout junction of the B3047 Alresford Road (Lady Croft Farm Roundabout)

Notice of Proposals of making of Various Road Traffic Regulation Orders Affecting the District of Winchester City Council

Winchester City Council as agents for Hampshire County Council proposes making the undermentioned road traffic regulation orders:-

"The Hampshire (A31 Alresford Road, Winchester) (Temporary 40mph Speed limit) Order 2007".

The effect of this order will be to introduce a temporary speed reduction order to be used when events are held which are likely to attract large volumes of traffic. Details are as follows:-

Road to be subject to 40mph Speed limit

A31 ALRESFORD ROAD, WINCHESTER for a distance of 6.4 kilometres between its junction with the A272 Petersfield Road and the roundabout junction of the B3047 Alresford Road (Lady Croft Farm Roundabout)

<u>FURTHER DETAILS</u>: a copy of this notice, the proposed orders, and maps showing the location and effect of the proposals, a statement of reasons and the order to be varied may be inspected during usual office hours at the following place:-
