### **TOPIC – PROPOSED TRAFFIC REGULATION ORDER – REVISION OF PERMIT HOLDERS WAITING RESTRICTIONS IN WINCHESTER IN ZONES B, N, Q, R, W & X AND INTRODUCTION OF NEW PERMIT HOLDERS ONLY BAYS IN HYDE STREET AND ST PETER STREET**

#### **SUMMARY**

- It is proposed to change the times of existing permit holders waiting restrictions in Cathedral View, Canute Road, Highcliffe Road, St Catherines Road, Water Lane, Durngate Terrace, Lawn Street (South Spur), Lawn Street (North Spur), Wharf Hill, Gladstone Street, Newburgh Street, Sussex Street and Tower Street as detailed on the attached schedules from the current restriction of "Permit Holders Only 8am to 6pm Monday to Saturday" to revised times of "Permit Holders Only 8am to 10pm Monday to Saturday".
- It is also proposed to introduce two new areas of "Permit Holders Only 8am to 10pm Monday to Saturday" restrictions in Hyde Street and St Peter Street as detailed on the attached schedules.
- The changes have been requested by residents and Local Councillors in the respective Wards to help alleviate parking problems.
- The proposal is in keeping with the Corporate Priorities in its attempt to improve traffic management, road safety and the environment.

- 5 letters of objections and one letter of support to the proposal as advertised were received in relation to the proposed parking bay in Hyde Street.
- No objections were received in relation to the other sites included in the proposal.
- The cost of the proposal will be funded through the Traffic Management Agency Agreement with Hampshire County Council. There will be no additional enforcement costs.
- A copy of plans showing the location of the proposal are attached.

**DECISION**

- It is recommended to revise the existing waiting restrictions in Cathedral View, Canute Road, Highcliffe Road, St Catherines Road, Water Lane, Durngate Terrace, Lawn Street (South Spur), Lawn Street (North Spur), Wharf Hill, Gladstone Street, Newburgh Street, Sussex Street and Tower Street to “Permit Holders Only 8am to 10pm Monday to Saturday” as advertised and the City Secretary and Solicitor be authorised to make the necessary order.
- It is recommended to withdraw the proposal to introduce “Permit Holders Only 8am to 10pm Monday to Saturday” in Hyde Street.
- It is recommended to introduce “Permit Holders Only 8am to 10pm Monday to Saturday” as advertised in St Peter Street and the City Secretary and Solicitor be authorised to make the necessary order
