SUMMARY

- Further to the new development at this location it is proposed to extend the existing "No Waiting At Any Time" restrictions in Spring Lane, Colden Common to facilitate the introduction of traffic signals at its junction with Main Road.
- It is proposed to introduce "No Waiting At Any Time" restrictions in the new road serving the development (Francis Copse) again in order to facilitate the introduction of traffic signals at its junction with Main Road.
- The changes are in accordance with the planning application/legal agreements connected with the development.
- The proposal is in keeping with the Corporate Priorities in its attempt to improve traffic management, road safety and the environment.
- No objections were received in relation to the proposal as advertised.
- The cost of implementing the proposal is being funded by the developer. There will be no additional enforcement costs.
- A copy of the plan showing the location of the proposal is attached.
