## **SUMMARY**

In order the support the Housing Strategy, Core Strategy and planning policies it is desirable to commission an assessment of local housing markets. The housing market assessments (HMA) will provide information on a wide range of housing market issues, including the need for affordable housing. As housing markets do not reflect administrative boundaries HMAs need to be carried out on a sub-regional basis. In addition, there are potential savings if the assessment is carrying out be the local authorities acting collectively. It is therefore proposed that the City Council work in partnership with Basingstoke and Deane BC (BDBC), East Hampshire DC, Test Valley Borough Council, New Forest DC, Hampshire CC and the Government Office for the South East for this purpose.

A partnership steering group (which involves officer representatives from the City Council) has been established and BDBC have agreed that they will act as the procuring authority. In consultation with the steering group, BDBC will organise the procurement process, including advertising for potential providers, evaluating tenders and contracting with the selected provider. The contract between BDBC and the provider will require the provider to carry out

an assessment which will cover all the participating authorities' areas, and provide information to the authorities in such a form so that they can use the information to support the relevant strategies and policies. The steering group would oversee the assessment work carried out by the provider.

As BDBC will be the lead authority in the contract, they have asked each district/borough council to sign a partnership agreement, which will set out the role of BDBC and provide for the costs incurred in the procurement exercise to be shared between the participating authorities.

It is estimated that the likely cost to the City Council will be in the region of £40,000 Growth bids of £20,000 each have been made for the Strategic Housing and Strategic Planning budgets which are due to be considered by Council on 28 February 2007.

The agreement requires approval to be obtained from the City Council before any contract is entered into with a consultant and there is the ability to terminate the contract should it be unable to obtain budgetary or other approval. The consultants will be selected following a selection process that has included an OJEU (European Journal) advertisement.

The proposal has been discussed with the Portfolio Holder for Housing and Communities and meets with his approval.

The HMA will support the Corporate Strategy Objective of Homes and Jobs.

#### PROPOSED DECISION

That Basingstoke and Deane BC be authorised to procure a Housing Market Assessment on behalf of Winchester City Council and the other participating authorities, subject to prior budgetary approval and approval by the Director of Communities of the selected consultants.
