# **TOPIC - LEGAL SERVICES - CALL OFF CONTRACT**

#### PROCEDURAL INFORMATION

The Access to Information Procedure Rules – Part 4, Section 22 of the Council's Constitution provides for a decision to be made by an individual member of Cabinet.

In accordance with the Procedure Rules, the Corporate Director (Governance), the Chief Executive and the Head of Finance are consulted together with Chairman and Vice Chairman of the Principal Scrutiny Committee and all Members of the relevant Scrutiny Panel (individual Ward Members are consulted separately where appropriate). In addition, all Members are notified.

Five or more of these consulted Members can require that the matter be referred to Cabinet for determination.

# **SUMMARY**

- Most local authorities (including the City Council) require specialist external legal advice from time to time to supplement in-house provision.
- A number of local authorities in the south have collaborated on a joint
  procurement exercise with the objective of setting up a framework agreement
  for external legal advice involving a number of legal firms. Such arrangements
  have proved to be both cost-effective (in terms of the rates offered, which are
  discounted from the usual rates) and efficient (allowing appropriate firms to be
  selected quickly on the basis of the tendered rates, saving time and the cost
  of seeking quotes/tenders).

• The agreement would then allow participating local authorities to "call-off" legal work under the framework agreement at prices set out in the agreement.

- The procurement has been undertaken by members of the Southern Branch
  of the Association of Council Secretaries and Solicitors (AcSeS). The
  opportunity was advertised and a large number of firms expressed interest.
  Tenders were invited from a list of firms compiled following a selection
  exercise, and these tenders have been evaluated to identify those firms who
  will be included in the framework agreement.
- The Contracts Procedure Rules permit the use of such framework arrangements provided that the use of the framework has been approved. This Decision Notice therefore seeks approval of the framework arrangement to allow the City Council to call off legal work from the agreement as and when required.
- Entering into the framework agreement does not commit the Council to calling-off any work, nor is there any commitment to expenditure under the agreement unless and until work is ordered under it.

#### PROPOSED DECISION

That the use of the Framework Agreement for the Provision of Legal Services 2010, procured by the Southern Branch of AcSeS (on behalf of member local authorities), be approved for the purposes of Contracts Procedure Rule 2.4 (b) i.

# REASON FOR THE PROPOSED DECISION AND OTHER ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

- The use of framework arrangements is encouraged by Government and procurement specialists as a way of reducing procurement costs and achieving value for money.
- Entering into the framework does not commit the Council in any way, but does
  give it access to the preferential rates obtainable under the agreement, as
  well as reducing the time and cost of selecting providers of legal advice.
- Although the use of external legal advice has reduced in recent years, there
  are still situations where such advice is necessary or desirable. These include
  the need for particularly specialist advice, or where a third party is meeting the
  costs of the advice.
- The framework arrangements provide for appropriate indemnities and insurance to cover situations where negligent advice is received from a firm engaged under the agreement.

- Before any call-off is ordered under the agreement, officers will ensure that appropriate budgetary provision has been made to meet the costs of the particular advice which is being ordered.
