

PROPOSED TRAFFIC ORDER TO PROHIBIT STOPPING ON TAXI RANKS IN VARIOUS
STREETS IN WINCHESTER

Winchester City Council on behalf of Hampshire County Council propose making a traffic regulation order as follows :-

EFFECT OF ORDER: To prohibit vehicles stopping on Taxi Ranks unless they are Licensed Hackney Carriages plying for hire.

<u>SCHEDULE 1 – NO STOPPING (EXCEPT TAXIS AT ANY TIME)</u>		
NAME OF ROAD	SIDE	DESCRIPTION
HIGH STREET (B3331)	SOUTH	BETWEEN A POINT 6.5 METRES EAST OF ITS WESTERLY JUNCTION WITH COLEBROOK STREET AND A POINT 35.0 METRES EAST OF THAT JUNCTION
HIGH STREET (B3331) CENTRE LANE	SOUTH	BETWEEN ITS JUNCTION WITH KINGS ALFREDS STATUE AND A POINT 51.6 METRES WEST OF THAT JUNCTION
TANNER STREET	EAST	BETWEEN A POINT 63.3 METRES SOUTH OF ITS JUNCTION WITH FRIARSGATE AND A POINT 83.3 METRES SOUTH OF THAT JUNCTION
SILVER HILL	SOUTH	BETWEEN A POINT 38.0 METRES WEST OF ITS JUNCTION WITH TANNER STREET AND A POINT 27.0 METRES WEST OF THAT JUNCTION
<u>SCHEDULE 2 – NO STOPPING (EXCEPT TAXIS 7pm – 6am)</u>		
HIGH STREET	SOUTH	FROM A POINT 15.0 METRES NORTH WEST OF ITS JUNCTION WITH SOUTHGATE STREET TO A POINT 11.0 METRES SOUTH EAST OF ITS JUNCTION WITH TRAFALGAR STREET (A TOTAL DISTANCE OF 45 METRES)
