

WINCHESTER CITY COUNCIL
TEMPORARY ROAD CLOSURE – VARIOUS ROADS – 15/16 NO. 10

NOTICE IS HEREBY GIVEN that Winchester City Council as agents for Hampshire County Council has made an order on traffic management grounds to allow for routine maintenance works to be undertaken as follows:

ROADS TO BE CLOSED:

1. Bishopstoke Lane, Colden Common – between its junction with Stoke Common Road and its junction with Church Lane.
2. Calling Close, Colden Common – for its entire length.
3. High Street, Winchester – between its junction with Southgate Street and its junction with Upper High Street.
4. Jewry Street, Winchester – between its junction with St Georges Street and its junction with City Road.
5. Longwood Dean, Owselbury – between its junction with Longwood and its junction with Salt Lane.
6. Main Road, Colden Common – between its junction with Hensting Lane and its junction with Winchester Road.
7. Nursery Road, Alresford – between its junction with Jacklyns Lane and its junction with Sun Lane.
8. Portsmouth Road, Fishers Pond – between its junction with Main Road and a point 100 metres east of that junction.
9. Rectory Lane, Meonstoke – between its junction with Allens Lane and its junction with Buckshead Hill.
10. Tanfield Lane, Wickham – for its entire length.
11. Teglease Lane, Hambledon – between its junction with Coombe Lane and its junction with Teglease Down Lane.
12. Tithelands Lane, Bramdean – between its junction with Petersfield Road and Woodlands.
13. Westfield Drove, Beauworth – between its junction with Holden Lane and its junction with Beauworth Lane.
14. Winchester Road, Micheldever – between its junction with Duke Street and its junction with London Road.

ALTERNATIVE ROUTES:

1. Bishopstoke Lane, Colden Common – Church Road, Riverside, Fair Oak Road, Allen Drayton Way, Eastleigh Road, Botley Road, Winchester Road, Main Road, Church Lane.
2. Calling Close, Colden Common – none.
3. High Street, Winchester – Southgate Street, St Cross Road, Badger Farm Road, Romsey Road.
4. Jewry Street, Winchester – Jewry Street, High Street, Upper High Street, Galdstone Street, Sussex Street, City Road.
5. Longwood Dean, Owselbury – Longwood, Belmore Lane, Salt Lane.
6. Main Road, Colden Common – Main Road, Highbridge Road, Allbrook Hill, Twyford Road, Bishopstoke Road, Fair Oak Road, Eastleigh Road, Botley Road, Winchester Road.
7. Nursery Road, Alresford – Jacklyns Lane, West Street, East Street, Sun Lane.
8. Portsmouth Road, Fishers Pond – Portsmouth Road, Mortimers Lane, Winchester Road.
9. Rectory Lane, Meonstoke – Allens Lane, Warnford Road, Garrison Hill, Buckshead Hill.
10. Tanfield Lane, Wickham – none.
11. Teglease Lane, Hambledon – Coombe Lane, Chapel Street, High Street, Clanfield Road, Hyden Farm Lane, The Hangers, Brook Lane, Hambledon Road, Sheardley Lane.
12. Tithelands Lane, Bramdean – Petersfield Road, Woodlands Road, Woodlands.
13. Westfield Drove, Beauworth – Beauworth Lane, Holden Lane.
14. Winchester Road, Micheldever – Duke Street, Cowdown, London Road.

Alternative routes will be signposted at the time of closure. Individual road closures in the same area will be implemented consecutively and not simultaneously.

PERIOD OF CLOSURE:

From 6th May 2015 for a period of 12 months or until completion of the works.

Each road is only expected to be closed for the minimum period to facilitate the works. Exact durations will be notified on site.

With the exception of any emergency works, advance warning signs will be displayed approximately 2 weeks in advance of any road closure being enforced.

Reasonable facilities will be provided for access to adjacent premises while the work is being carried out.
