#### TEMPORARY ROAD CLOSURES - WINCHESTER DISTRICT.

NOTICE IS HEREBY GIVEN that Winchester City Council as agents for Hampshire County Council proposes to make an Order to allow for routine maintenance works to be carried out as follows:-

# **ROADS TO BE CLOSED:**

- 1. ALRESFORD DROVE, SOUTH WONSTON between its junction with West Hill Road North and its junction with Old Stoke Road. Alternative route West Hill Road North, Downs Road, Christmas Hill, Winchester Hill, Wonston Road, Old Stoke Road.
- 2. ANDOVER ROAD, MICHELDEVER STATION between its junction with Stockbridge Road to a point 400 metres east of that junction. Alternative route Stockbridge Road, Overton Road, Andover Road.
- 3. BEREWEEKE ROAD, WINCHESTER between its junction with Stockbridge Road and its junction with Andover Road. Alternative route Stockbridge Road, Stoney Lane, Andover Road.
- 4. CHURCH LANE, COLDEN COMMON between its junction with Main Road and its junction with Bishopstoke Lane. Alternative route Brambridge, Highbridge Road, Spring Lane, Main Road.
- 5. CROOKED WALK LANE, SOUTHWICK between its junction with Portchester Lane and its junction with Southwick Road. Alternative route Portchester Lane, B2177 Southwick Road.
- 6. MAIN ROAD, NORTHINGTON between its junction with the A33 London Road and its junction with Stratton Lane. Alternative route A33 London Road, Church Bank Road, Stratton Lane.
- 7. NEWLANDS LANE, DENMEAD between its junction with Closewood Road and its junction with Purbrook Heath Road. Alternative route Closewood Road, B2150 Hambledon Road, Maurepas Way, London Road, Purbrook Heath Road.
- 8. LONGWOOD DEAN, OWSLEBURY between its junction with Lane End Down Lane and its junction with Longwood Dean Lane. Alternative route Preshaw Lane, Beauworth Road, A272 Petersfield Road, Longwood.
- 9. SCIVIERS LANE, DURLEY between its junction with the B2177 Winchester Road and its junction with Durley Hall Lane. Alternative route B2177 Winchester Road, Winters Hill, Sciviers Lane.
- 10. STAKES LANE, UPHAM between its junction with the B2177 Winchester Road and its junction with Peak Lane. Alternative route B2177 Winchester Road, Upham Street, Church Street, Stakes Lane.

11. WOODMAN LANE, PITT between its junction with Enmill Lane and its junction with Sarum Road. Alternative route - Enmill Lane, A3090/B3040 Romsey Road, Kilham Lane, Sarum Road.

#### **ALTERNATIVE ROUTES:**

As indicated above in relation to each road.

# PERIOD OF CLOSURE:

From and including the 1<sup>st</sup> May 2008 for a period of eleven months or until completion of the works whichever is sooner. (**Notwithstanding the above it is expected that any one closure will be required for no longer than 4 weeks**) With the exception of any emergency works, advance warning signs will be displayed approximately 2 weeks in advance of any closure being enforced.

Reasonable facilities will be provided to allow access to adjacent premises while the work is being carried out.
