# Notice of Making of Various Road Traffic Regulation Orders Affecting the District of Winchester City Council 

On $16^{\text {th }}$ June 2009 Winchester City Council as agents for Hampshire County Council made the undermentioned road traffic regulation orders:-

## 1. The Hampshire (Various Roads, Winchester) (Parking Places and Restriction of Waiting) (Controlled Zone) Order 2002 (Variation No.49) Order 2009.

The Order is to be on an experimental basis for a maximum period of 18 months and the Council will, in due course consider whether the provisions of the Order should continue in force indefinitely.

OBJECTIONS to the Experimental Order: Within a period of six months from when the experimental Order comes into force or, if the Order is subsequently varied or modified within six months of the date of the coming into force of such variation or modification any person may object to the making of an order for the purpose of such indefinite continuation.

Each of the above orders will come into operation on $19^{\text {th }}$ June 2009.
Copies of the orders, maps showing the locations and a statement of reasons for each of the above orders and the orders to be varied may be inspected during usual office hours at the City Offices, Colebrook Street, Winchester.
Any person who wishes to question the validity of any of the above orders or any of the provisions of the orders on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or of any instrument made under it has not been complied with may, within six weeks of the date when the orders were made apply to the High Court for that purpose.
