NOTICE IS HEREBY GIVEN that Winchester City Council as agents for Hampshire County Council proposes to make an order on traffic management grounds to allow for routine maintenance works to be undertaken as follows:

ROADS TO BE CLOSED:

- 1. Crossways Lane, Denmead between White Horse Lane and Edneys Lane.
- 2. Crossways Road, Denmead between Edneys Lane and Anmore Road.
- 3. <u>B2150 Hambledon Road, Denmead</u> between Sunnymead Drive and Forest Road.
- 4. Harrow Gate Lane, Denmead between Rushmere Lane and Pithill Lane.
- 5. <u>Kidmore Lane, Denmead</u> between Mays Lane and Hambledon Road.
- 6. Mays Lane, Denmead between Pithill Farm Lane and White Horse lane.
- 7. Mays Well Lane, Denmead between Harrow Gate Lane and Pithill Farm Lane.
- 8. <u>Pithill Farm Lane, Denmead</u> between Harrow Gate Lane and Mays Lane.
- 9. Tanner Lane, Denmead between Kidmore Lane and White Horse Lane.
- 10. White Horse Lane, Denmead between Mays Lane and Edneys Lane.

ALTERNATIVE ROUTES:

- 1. <u>Crossways Lane, Denmead</u> Edneys Lane, White Horse Lane.
- 2. Crossways Road, Denmead Edneys Lane, Anmore Road, Anmore Lane.
- 3. <u>B2150 Hambledon Road, Denmead</u> B2150 Hambledon Road, A3 London Road, B2177 Portsdown Hill Road/Southwick Road, A32 Fareham Road/Wickham Road, B2150 Hambledon Road
- 4. Harrow Gate Lane, Denmead Rushmere Lane, Pithill Lane.
- 5. Kidmore Lane, Denmead Mays Lane, White Horse Lane, Anmore Road.
- 6. <u>Mays Lane, Denmead</u> Edneys Lane, Anmore Road, B2150 Hambledon Road, Kidmore Lane.
- 7. Mays Well Lane, Denmead Harrow Gate Lane, Pithill Lane.
- 8. Pithill Farm Lane, Denmead Harrow Gate Lane, Mays Well Lane.
- 9. <u>Tanner Lane</u>, <u>Denmead</u> White Horse Lane, Mays Lane, Kidmore Lane.
- 10. White Horse Lane, Denmead Crossways Road, Edneys Lane.

Alternative routes will be signposted at the time of closure. Individual road closures in the same area will be implemented consecutively and not simultaneously.

PERIOD OF CLOSURE:

From 1st November 2011 for a period of 12 months or until completion of the works.

Each road is only expected to be closed for two separate periods of approximately 1 week each.

With the exception of any emergency works, advance warning signs will be displayed approximately 2 weeks in advance of any road closure being enforced.

Reasonable facilities will be provided to allow access to adjacent premises while the work is being carried out.
