NOTICE IS HEREBY GIVEN that Winchester City Council as agents for Hampshire County Council proposes to make an order on traffic management grounds to allow for routine maintenance works to be undertaken as follows:

ROADS TO BE CLOSED:

- 1. <u>Bighton Hill/Sutton Wood Lane, Ropley</u> between its junction with the A31 Winchester Road and its junction with Goscombs Lane.
- 2. <u>Clifton Road, Winchester</u> for its entire length.
- 3. Grove Road, Shawford for its entire length.
- 4. <u>Legion Lane path, Kings Worthy</u> between Legion Lane and Campion Way.
- 5. Northbrook, Micheldever for its entire length.
- 6. <u>School Lane, Denmead</u> between its junction with the B2150 Hambledon Road and its junction with Inhams Lane.
- 7. South Close, New Alresford for its entire length.
- 8. St Peter Street, Winchester for its entire length.
- 9. Tanfield Lane, Wickham for its entire length.
- 10. <u>The Hangers, Bishops Waltham</u> between its junction with Corhampton Lane and its junction with Sailors Lane.

ROADS TO BE CLOSED:

- 1. <u>Bighton Hill/Sutton Wood Lane, Ropley</u> A31 Winchester Road, Northside Lane, Goscombs Lane.
- 2. Clifton Road, Winchester St Pauls Hill, Clifton Terrace, Romsey Road...
- 3. Grove Road, Shawford Fairfield Road, Cross Road, Southdown Road.
- 4. Legion Lane, Kings Worthy Legion Lane, Wesley Road, Gillingham Close.
- 5. Northbrook, Micheldever Duke Street, A33 Basingstoke Road, Larkwhistle Farm Road.
- 6. School Lane, Denmead B2150 Hamledon Road, Uplands Road, Thompsons Lane.
- 7. South Close, New Alresford None.
- 8. St Peter Street, Winchester St Georges Street, Jewry Street North Walls.
- 9. Tanfield Lane, Wickham None.
- 10. <u>The Hangers, Bishops Waltham</u> B3035 Corhampton Lane, A32 Garrison Hill/Midlington Road/Wickham

Road/Droxford Road, A334 Fareham Road/Winchester Road, B2177 Winchester Road, B3035 The Hangers.

Alternative routes will be signposted at the time of closure. Individual road closures in the same area will be implemented consecutively and not simultaneously.

PERIOD OF CLOSURE:

From 1st September 2014 for a period of 12 months or until completion of the works.

Each road is only expected to be closed for the minimum period to facilitate the works.

Exact durations will be notified on site.

With the exception of any emergency works, advance warning signs will be displayed approximately 2 weeks in advance of any road closure being enforced.

Reasonable facilities will be provided for access to adjacent premises while the work is being carried out.
