#### ROADS TO BE CLOSED:

- 1. <u>Bar End Road/Chesil Street, Winchester</u> between its junction with the A31 St Catherines Way and its junction with Magdalen Hill.
- 2. <u>Donigers Close, Swanmore</u> for its entire length.
- 3. <u>Forest Road</u>, <u>Worlds End</u> between its junction Southwick Road and its junction with Ervills Road.
- 4. <u>Houchin Street, Bishops Waltham</u> between its junction with Bank Street and its junction with The Square.
- 5. <u>Magdalen Hill, Winchester</u> between its junction with Chesil Street and its junction with Alresford Road.
- 6. <u>North Drive, Littleton</u> between its junction with Fyfield Way and its junction with Main Road.
- 7. <u>Old Kennels Lane, Oliver's Battery</u> between its junction with Millers Lane and its junction with Oliver's Battery Road South.
- 8. <u>Stoney Lane, Winchester</u> between its junction with Stockbridge Road and its junction with Andover Road.
- 9. <u>St Pauls Hill, Winchester</u> between its junction with Stockbridge Road and its junction with Upper High Street.
- 10. <u>Winchester Road, Micheldever</u> between its junction with the A33 Basingstoke Road and its junction with Duke Street.

#### ROADS TO BE CLOSED:

1. <u>Bar End Road/Chesil Street, Winchester</u> – Magdalen Hill, Alresford Road, A31 Petersfield Road, A31 St Catherines Way.

2. <u>Donigers Close, Swanmore</u> – None.

3. <u>Forest Road, Worlds End</u> – Ervills Road, Fareham Road, West Hill Hambledon Road, Southwick Road.

4. Houchin Street, Bishops Waltham - Bank Street, Shore Lane, Coppice Hill,

Upperbasingwell Street, The Square.

5. <u>Magdalen Hill, Winchester</u> – Alresford Road, A31 Petersfield Road, A31 St Catherines Way.

6. North Drive, Littleton – Fyfield Road, Main Road.

7. Old Kennels Lane, Oliver's Battery – Millers Lane, A3090 Romsey Road, Badger Farm Road, Oliver's Road South.

8. <u>Stoney Lane, Winchester</u> – Stockbridge Road, Bereweeke Road, Andover Road.

9. <u>St Pauls Hill, Winchester</u> – Stockbridge Road, Chilbolton Avenue, Romsey Road, Clifton Terrace.

10. <u>Winchester Road, Micheldever</u> – A33 Basingstoke Road, Cowdown, Duke Street.

Alternative routes will be signposted at the time of closure. Individual road closures in the same area will be implemented consecutively and not simultaneously.

# PERIOD OF CLOSURE:

From 5<sup>th</sup> November 2014 for a period of 12 months or until completion of the works.

# Each road is only expected to be closed for the minimum period to facilitate the works.

# Exact durations will be notified on site.

With the exception of any emergency works, advance warning signs will be displayed approximately 2 weeks in advance of any road closure being enforced.

Reasonable facilities will be provided for access to adjacent premises while the work is being carried out.
