NOTICE IS HEREBY GIVEN that Winchester City Council as agents for Hampshire County Council has made an order on traffic management grounds to allow for routine maintenance works to be undertaken as follows:

ROADS TO BE CLOSED:

- 1. <u>Anmore Road, Denmead</u> between its junction with Hambledon Road and its junction with Mill Lane.
- 2. <u>Bank Street, Bishops Waltham</u> between its junction with Lower Lane and its junction with Free Street..
- 3. <u>Bent Lane, Hambledon-Denmead</u> between its junction with Fareham Road and its junction with Bunns Lane.
- 4. <u>Bury Lodge Lane, Hambledon</u> between its junction with Hambledon Road and its junction with Rushmere Lane.
- 5. <u>Calcot Lane, Curdridge</u> between its junction with Botley Road and its junction with Mill Lane
- 6. Canford Close, Shedfield for its entire length.
- 7. <u>Chase Grove, Waltham Chase</u> between its junction with Winchester Road and its junction with Curdridge Lane.
- 8. <u>Clewers Lane, Waltham Chase</u> between its junction with Winchester Road and its junction with Clewers Hill.
- 9. <u>Closewood Road, Denmead</u> between its junction with Newlands Lane and its junction with Hambledon Road.
- 10. <u>Longwood Dean, Owslebury</u> between its junction with Petersfield Road and its junction with Lane End Down Lane.
- 11. <u>Sheepwash Lane, Denmead</u> between its junction with Belney Lane and its junction with Furzley Road.
- 12. Well Lane, Swanmore between its junction with Vicarage Lane and its junction with Park Lane.

- 1. Anmore Road, Denmead Hambledon Road, Mill Road.
- 2. Bank Street, Bishops Waltham Lower Lane, Corhampton Road, Free Street.
- 3. Bent Lane, Hambledon-Denmead Fareham Road, Bunns Lane.
- 4. Bury Lodge Lane, Hambledon Rushmere Lane, Hambledon Road.
- 5. Calcot Lane, Curdridge Botley Road, Wangfield Lane, Netherhill Lane, Mill Lane.
- 6. Canford Close, Shedfield none.
- 7. Chase Grove, Waltham Chase Winchester Road, Curdridge Lane.
- 8. Clewers Lane, Waltham Chase Winchester Road, Clewers Hill.
- 9. <u>Closewood Road, Denmead</u> Newlands Road, Furzley Road, Forest Road, Hambledon Road.
- 10. Longwood Dean, Owslebury Petersfield Road, Lane End Down Lane.
- 11. Sheepwash Lane, Denmead Newlands Lane.
- 12. Well Lane, Swanmore Vicarage Lane, Park Lane..

Alternative routes will be signposted at the time of closure. Individual road closures in the same area will be implemented consecutively and not simultaneously.

PERIOD OF CLOSURE:

From 6th May 2015 for a period of 12 months or until completion of the works.

Each road is only expected to be closed for the minimum period to facilitate the works. Exact durations will be notified on site.

With the exception of any emergency works, advance warning signs will be displayed approximately 2 weeks in advance of any road closure being enforced.

Reasonable facilities will be provided for access to adjacent premises while the work is being carried out.
