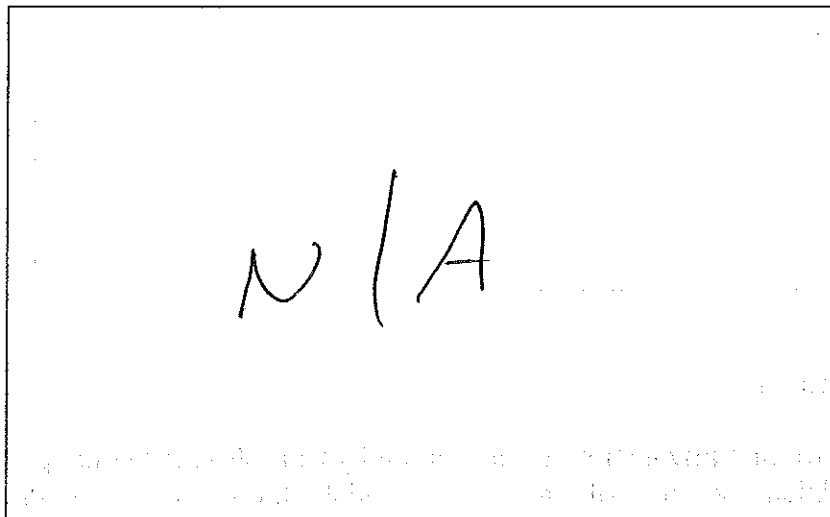

This means any tenancy where (to your knowledge) –

- (a) the landlord is the Twyford Parish Council; AND
- (b) the tenant is a body in which you, or your partner, have a beneficial interest;



7 Securities

This means any beneficial interest in securities of a body where –

- (a) that body (to your knowledge) has a place of business or land in the administrative area of the Twyford Parish Council; AND
- (b) either -
 - (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued shared capital of that body; OR

4 Land

This means any beneficial interest in land within the area of the Twyford Parish Council of yourself, or your partner.

NOTE: Land includes buildings, including your home. It does not include an easement, servitude, interest or rights in or over land which does not include the right for you or your partner (alone or with another) to occupy the land or to receive income.

5 Licences



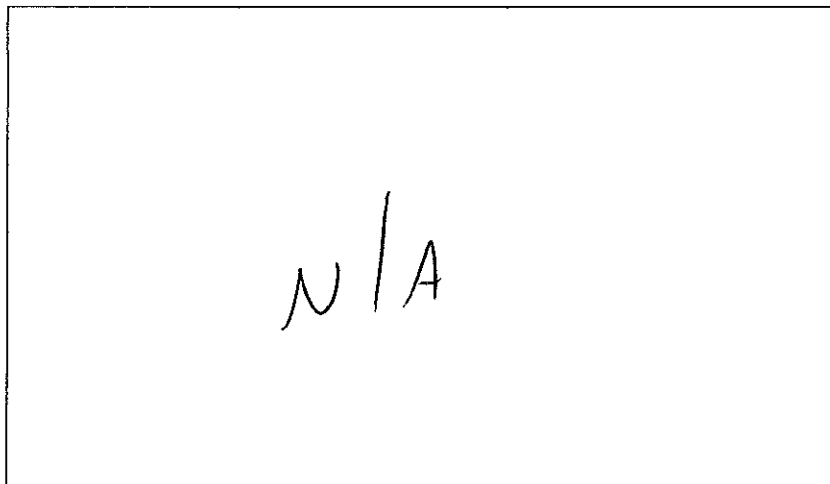

NOTE: A body in which you or your partner have a beneficial interest means a firm in which you or your partner is a partner, or a body corporate of which you or your partner is a director, or in the securities of which you or your partner has a beneficial interest.

- (c) to knowingly or recklessly provide information under Section 30(1), 31(2), 31(3), or 31(7) of the Localism Act which is false or misleading;
