- 5. Have all options been exhausted in relation to identifying and allocating sites for showpeople? Have the Council considered using its CPO powers to provide sites to remedy the shortfall?
- 6. Can the Council please provide an update on outstanding planning issues with sites such as the Piggeries and Carousel Park and how this affects the supply of pitches?
- 7. Do all the 'sites with planning permission' identified in row b of the table at the bottom of page 13 of the DPD have a permanent planning permission? If not, can the Council please provide details of all of these permissions. In addition, are any of the permissions personal to the occupants? If so, can the Council please provide details.
