Hi Sarah,

As discussed, in relation to the land at The Chairmakers Arms, from 2013 aerial photographs and photos taken by officers on site I have some observations.

What appear to be coniferous trees have been removed from the western entrance to
the site. This habitat could have supported nesting birds and commuting bats amongst
other protected species. Basic surveys would be required to inform the council what
was present and how it could be impacted by the proposals. This habitat would not be
considered priority from an ecological point of view.

From the information available (aerial photos) the land would not be of high ecological value.

In line with NPPF and NERC we would look for biodiversity enhancement measures, including provision of features such as bird/bat nesting/roosting provision.
