I refer to the above details which relate to an appeal that has been made to the Secretary of State against an enforcement notice issued by Winchester City Council on 10 May 2019.

Please refer to the attached enforcement notice for the reasons for issuing, the steps that are required to be taken and the times for compliance.

The appellant has appealed against the notices on the following grounds:

Ground (a) – that planning permission should be granted for what is alleged in the notice.

Ground (f) - The steps required to comply with the requirements of the notice are excessive, and lesser steps would overcome the objections.

The appeal will be determined on the basis of **written representations**. The procedure to be followed is set out in the Town and Country Planning (Enforcement) (Written Representations Procedure) (England) Regulations 2002.
