OUR VISION

Winchester Community Safety Partnership aims to reduce some of the main causal factors that increase risks related to crime & disorder. We will strengthen our existing arrangements and develop opportunities in order to take a proactive stance against those who pose a threat to the feelings of safety and sense of community in our rural and urban areas across the district.

WHAT WE KNOW:

- There are many causal effects that impact on those who are perpetrators and victims of crime and disorder; mental health issues, Adverse Childhood Experiences (ACE), substance dependency, domestic violence and abuse.
- That Covid-19 may have had far reaching impacts upon crime rates and individuals gaining access to support services.
- Drug trafficking/ County Lines is still a concern for residents and partners alike as it impacts on the fear of crime and presents a greater risk to those most vulnerable.
- Environmental crime which includes fly tip continues to be a blight on society and requires greater collaboration with private landowners in our quest to take a zero tolerance approach to those identified as perpetrators.
- Anti-Social Behaviour (ASB) is still having an adverse impact on individuals and communities.

PRIORITY ONE

Domestic Violence & Abuse **OBJECTIVE 1**: To increase the number of Formal Action Taken (FAT) outcomes.

OBJECTIVE 2: To reduce the total number of repeat domestic abuse victims and offenders.

OBJECTIVE 3: Ensure delivery of recommendations arising from the serious case review, monitor progress via an annual review.

PRIORITY TWO Drug Related

Harm

OBJECTIVE 1: Reduce the number of hotspot locations.

OBJECTIVE 2: To increase the number of Formal Action Taken (FAT) outcomes by utilising a range of disposal options, including out of court disposals when appropriate.

OBJECTIVE 3: To reduce drug related violence incidents.

PRIORITY THREE Quality of Life

OBJECTIVE 1: Reduce the number of ASB victims and repeat offenders.

OBJECTIVE 2: Continue to take a zero tolerance approach to fly tipping incidents and increase the number of positive enforcement interventions

OBJECTIVE 3: Reduce the opportunity for those who target our most vulnerable.

OUTCOMES WE WILL:

- Undertake further research to identify the actual impact that covid-19 has had on crime & disorder post lockdown.
- Improved evidence collection in relation to reported domestic abuse.
- Continue to work proactively with the police to help them identify the risk factors around our most vulnerable residents in relation to County Lines and to maximise opportunities for out of court disposals.
- Increase our collaboration with private landowners to identify fly tip perpetrators and encourage waste clearance in a timely fashion.
- Aim to increase our Formal Action Taken (FAT) outcomes in relation to assault with injury offences.
- Achieve greater satisfaction levels from those who raise concerns about ASB.
