

## Winchester City Council Grants – December 2020 Newsletter

### SMALL GRANTS – UP TO £500

#### **Open for applications – Town Forum and District**

This scheme aims to make small grants easily available to local voluntary and community groups. Grants are quick and easy to apply for, and we will offer you advice whenever you need it. The grants of up to £500 are available for one-off pieces of expenditure if on projects, equipment and other items which will help your organisation to do more, to reach more people, to provide better services or to try something different.

We are also encouraging organisations to apply for Coronavirus (COVID-19) related activities which support our themes of: Dealing with peoples and communities needs and striving for positive change

Items of expenditure for example could be as follows (but not exclusive to):

- Trialling a different way of working during these socially distanced times
- Buying different or updated technology
- Increasing or updating your resources
- Improving digital connectivity to enhance service user engagement
- Activities to increase your support to vulnerable individuals
- Creating a COVID safe environment in which to deliver your service
- Provision of equipment including Personal protective equipment (PPE)

Should your application be eligible and suitable for funding we would like you to attend a virtual panel meeting in order for us to have a brief discussion with regards to your application. You will be advised on the day if your organisation will receive the funding you requested. Small Grant Panel Meetings will be held on a 6 week rolling basis via an online system (usually MS Teams) but we can assist you with this if required.

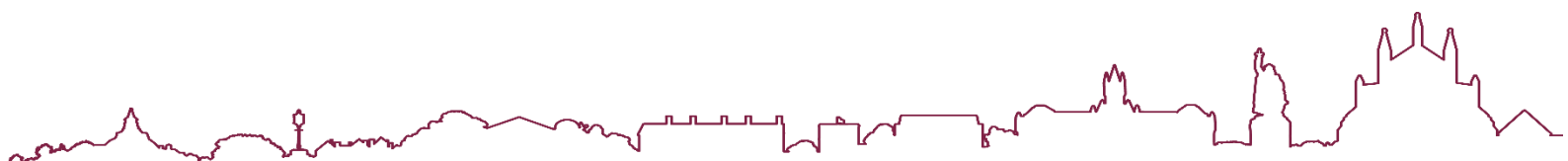

## CROWDFUND WINCHESTER

### COMMUNITIES POSITIVE CHANGE FUND TOWN COMMUNITY FUND

*Relaxation of criteria until 31 March 2021*

The Council appreciates that not for profit organisations are facing unprecedented times and difficult decisions regarding income generation and a rise in demand for service provision. The Council is also very aware of the invaluable support that these organisations provide to our most vulnerable communities and residents.

Therefore, until March 31 2021 we are relaxing our criteria to encourage not for profit organisations to apply for funding to support additional costs that they may have incurred or are incurring to deliver their services.

Organisations may apply for funding in respect of the following costs, where they can demonstrate evidence of increased demand:

- Additional staffing
- Alternative/additional premises
- Car / transport hire
- Increased volunteer expenses
- New or updated technology in order to increase reach
- Creating a COVID safe environment in which to deliver your service
- Provision of equipment including Personal protective equipment (PPE)

If your organisation is eligible, the council will consider matching up to 50% of the project costs or £2000 (whatever is less).

*Applicants already in receipt of our Strategic and Priority Outcomes annual funding are able to apply for costs that are over and above core activities.*

**Communities Positive Change Fund overview:** The 'Communities Positive Change Fund' is keen to support not-for-profit organisations and businesses within the Winchester District that provide services/activities which **deal with communities needs**, such as isolation, low income, homelessness, mental health and physical inactivity. We are also wishing to support those applicants who are **striving for positive change** around environmental quality, increasing usage of digital applications, services and products, enhancing sustainability, green technologies, creativity and innovation and business growth.

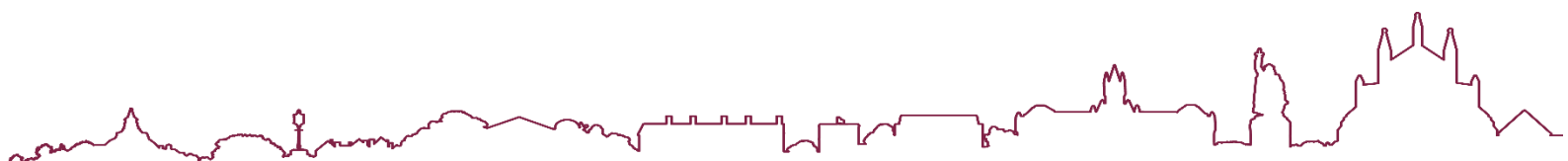
